An Act to amend the Housing (Miscellaneous Provisions) Act 2009 to provide for universal access to social housing by abolishing income-related criteria.

Be it enacted by the Oireachtas as follows:

Amendment of section 20 of Housing (Miscellaneous Provisions) Act 2009

10

1. Section 20 of the Housing (Miscellaneous Provisions) Act 2009 is amended in subsection (4) by the deletion of paragraphs (a), (b), (c), (d) and (g).

Short title and commencement

2. (1) This Act may be cited as the Universal Access to Social Housing (Abolition of Income Limits) Act 2026.
- (2) This Act shall come into operation on such day as the Minister for Housing, Local Government and Heritage may by order appoint not being later than 90 days from its promulgation by the President.
