An Act to amend the Planning and Development Act 2000 and to repeal section 97(3)(b).

Be it enacted by the Oireachtas as follows:

Definitions

1. In this Act—

“Act of 2002” means the Planning and Development (Amendment) Act 2002;

“Principal Act” means the Planning and Development Act 2000.

Amendment of section 97 (Development to which section 96 shall not apply) of Principal Act

2. Section 97 of the Principal Act (as amended by section 5 of the Act of 2002) is amended in subsection (3) by the deletion of paragraph (b).

Short title, collective citation and construction

3. (1) This Act may be cited as the Planning and Development (Provision of Public Housing) Act 2026.

(2) The Planning and Development Acts 2000 to 2018 and this Act may be cited together as the Planning and Development Acts 2000 to 2026.
