Be it enacted by the Oireachtas as follows:

Short title and commencement

10

1. (1) This Act may be cited as the Agri-Food Regulator (Amendment) Act 2026.
- (2) This Act shall come into operation on the day of its passing.
- (3) The amendments effected by this Act shall be fully operational within three months of its passing, and the Agri-Food Regulator shall take all necessary steps to give full effect to *section 2* within that period. 15

Amendment of Agricultural and Food Supply Chain Act 2023

2. The Principal Act is amended, in section 12(3), by the substitution of the following paragraph for paragraph (d):

- “(d) compel businesses within the agricultural and food supply chain to provide any data impacting upon price and margins considered necessary, including— 20
- (i) prices paid and received,
 - (ii) margin,
 - (iii) financial and accounting data,
 - (iv) throughput of agricultural produce, 25
 - (v) data in relation to policy and procedure,
 - (vi) employment status, and
 - (vii) salary.”.
