An Act to amend the Dublin Transport Authority Act 2008 to enable the National Transport Authority to provide additional public transport infrastructure in the State; and to provide for related matters. 5

Be it enacted by the Oireachtas as follows:

Definition

1. In this Act, “Act of 2008” means the Dublin Transport Authority Act 2008. 10

Amendment of section 2 of Act of 2008

2. Section 2 of the Act of 2008 is amended, in the definition of “road authority”, by the substitution of “has the meaning assigned to it by the Act of 1993” for “has the meaning assigned to it by the Act of 1993 and, except where otherwise specified, refers only to road authorities in the GDA”. 15

Amendment of section 44 of Act of 2008

3. Section 44 of the Act of 2008 is amended, in subsection (1), by the substitution of “public transport infrastructure in the State” for “public transport infrastructure in the GDA”.

Short title and collective citation 20

4. (1) This Act may be cited as the Dublin Transport Authority (Amendment) Act 2026.
- (2) The National Transport Authority Acts 2008 to 2016, section 47 of the Road Traffic and Roads Act 2023 and this Act may be cited together as the National Transport Authority Acts 2008 to 2026.
