An Act to provide for additional requirements, relating to residency in the State, to be satisfied in order to be eligible for social housing support; to provide for an appeal of certain decisions relating to social housing support; for those purposes to amend the Housing (Miscellaneous Provisions) Act 2009; to provide for additional eligibility criteria for access to certain services provided to homeless persons under section 10 of the Housing Act 1988; to provide for withdrawal of such services in certain cases; to provide for an appeal in respect of such withdrawal; for those purposes to amend the Housing Act 1988; to make provision in relation to the conduct of mediations, adjudications and Tribunal hearings, and the determination of disputes, by the Residential Tenancies Board, and the enforcement of such determinations; to increase the penalties for summary offences and to provide for the service of fixed payment notices in respect of certain offences under the Residential Tenancies Act 2004; to provide that the Residential Tenancies Act 2004 shall not apply to certain dwellings; for those and other purposes to amend that Act; and to provide for related matters.

Be it enacted by the Oireachtas as follows:

PART 1

PRELIMINARY AND GENERAL

Short title, collective citation, construction and commencement

1. (1) This Act may be cited as the Housing and Residential Tenancies (Miscellaneous Provisions) Act 2026. 25
(2) *Parts 3 and 4* and the Housing Acts 1966 to 2024 may be cited together as the Housing Acts 1966 to 2026 and shall be construed together as one.
(3) *Part 5* shall be included in the collective citation Residential Tenancies Acts 2004 to 2026 and shall be construed together as one with those Acts. 30

- (4) This Act, other than *section 40*, shall come into operation on such day or days as the Minister may by order or orders appoint either generally or with reference to any particular purpose or provision and different days may be so appointed for different purposes or different provisions.

Definition

5

2. In this Act, “Minister” means the Minister for Housing, Local Government and Heritage.

Repeal of provisions of Residential Tenancies Act 2004

3. Subsections (3) and (4) of section 39A of the Residential Tenancies Act 2004 are repealed.

PART 2

AMENDMENTS TO HOUSING ACT 1988

Interpretation (*Part 2*)

4. In this Part, “Act of 1988” means the Housing Act 1988.

Amendment of section 1 of Act of 1988

5. Section 1 of the Act of 1988 is amended by the insertion of the following definition:

15

“ ‘Act of 2009’ means the Housing (Miscellaneous Provisions) Act 2009;”.

Amendment of section 10 of Act of 1988

6. Section 10 of the Act of 1988 is amended—

- (a) in subsection (1), by the substitution of “A housing authority may, subject to section 10A and to such regulations” for “A housing authority may, subject to such regulations”,

- (b) in subsection (8)—

- (i) in paragraph (a)(ii), by the substitution of “own resources,” for “own resources, or”,

25

- (ii) by the insertion of the following paragraphs after paragraph (b):

“(c) that person (whether as a household within the meaning of section 18A of the Act of 2009 or part of such a household) refuses one reasonable offer of a form of support referred to in paragraph (a), (b) or (d) of section 19(2) of that Act, or

30

- (d) that person intentionally or recklessly engages in conduct which causes death or serious harm to another person in the accommodation or lodgings,”

and

- (iii) by the substitution of “the authority may determine that such accommodation or lodgings shall no longer be made available to the person and may require the person to vacate the accommodation or lodgings” for “the authority may cease to have such accommodation or lodgings made so available and may require the person to vacate the accommodation or lodgings”, 5
- (c) in subsection (10), by the substitution of “to determine if a person is homeless or to determine, under section 10A(1), if a person is eligible to access arrangements, assistance or accommodation provided by a housing authority under subsection (1)” for “to determine if a person is homeless”, and 10
- (d) by the insertion of the following subsections after subsection (11):
 - “(12) Where, by virtue of subsection (1)(c), accommodation is provided or rented, or where lodgings are arranged, for a person and a child who normally resides with the person, a housing authority shall have regard to the best interests of that child when considering available accommodation or lodgings for that person under subsection (1)(c). 15
 - (13) In this section—
 - ‘child’ means a person who has not attained the age of 18 years;
 - ‘serious harm’ means injury which creates a substantial risk of death or which causes serious disfigurement or substantial loss or impairment of the mobility of the body as a whole or of the function of any particular bodily member or organ.”. 20

Insertion of new sections 10A and 10B in Act of 1988

7. The Act of 1988 is amended by the insertion of the following new sections after section 10: 25

“Residency requirements

- 10A.** (1) A person shall not be eligible to access arrangements, assistance or accommodation provided by a housing authority by virtue of section 10(1) unless the authority, having carried out an assessment, is satisfied that the person, and any person who normally resides with that person or who might reasonably be expected to reside with that person, meets the requirements referred to in section 20A(1) of the Act of 2009. 30
- (2) For the purposes of subsection (1), section 20(7) of the Act of 2009, in so far as it relates to section 20A of that Act, and the said section 20A, shall apply subject to the following modifications: 35
- (a) a reference to a household shall be read as a reference to—
 - (i) a homeless person who, but for being such a person, would live alone,
 - (ii) a group of persons comprising a homeless person and one or more other persons who normally reside with that person, or 40

- (iii) a group of persons comprising a homeless person and one or more other persons who might reasonably be expected to reside with that person;
- (b) a reference to social housing support shall be read as a reference to arrangements, assistance or accommodation provided under section 10; 5
- (c) a reference to a social housing assessment shall be read as a reference to an assessment for the purposes of subsection (1);
- (d) any other necessary modifications.
- (3) Subject to subsection (4), where a person does not meet the eligibility requirements referred to in subsection (1) and, in the opinion of the housing authority, that person is seeking alternative arrangements, assistance or accommodation and no such alternative arrangements, assistance or accommodation are available to that person, a housing authority may, on the date on which such opinion is formed, make arrangements for, or provide assistance or accommodation to, that person by virtue of section 10(1) between the hours of 8 p.m. on that date and 8 a.m. on the date immediately following that date. 10 15
- (4) Where a housing authority has made arrangements for, or provided assistance or accommodation to, a person under subsection (3), the housing authority may make arrangements for, or provide assistance or accommodation to, that person for a further period between the hours of 8 p.m. and 8 a.m. on the date immediately following the date on which the opinion referred to in subsection (3) was formed where, in the opinion of the authority, alternative arrangements, assistance or accommodation continue to be unavailable to that person. 20 25
- (5) A housing authority may refuse to make arrangements under subsection (3) where alternative arrangements, assistance or accommodation have been refused by the person within a period of 24 months prior to seeking accommodation under section 10(1). 30
- (6) Where, under subsections (3) or (4), arrangements are made, or assistance or accommodation are provided, such arrangements, assistance or accommodation shall not be considered for the purposes of determining, under section 20A of the Act of 2009, as applied by subsection (1), whether the person in respect of whom such arrangements have been made or to whom such assistance or accommodation has been provided, is habitually resident in the State. 35
- (7) Subsection (3) shall not apply to:
 - (a) an applicant within the meaning of section 2 of the International Protection Act 2015; 40
 - (b) a person to whom section 60 of the International Protection Act 2015 applies;

- (c) an applicant within the meaning of section 2 of the International Protection Act 2026;
- (d) a person to whom section 237 of the International Protection Act 2026 applies.

Appeal of determination under section 10(8) 5

- 10B.** (1) Where a housing authority determines, under section 10(8), that accommodation or lodgings shall no longer be made available to a person, that person may appeal that determination.
- (2) An appeal under subsection (1) shall be made to the chief executive of the housing authority concerned, or, in the case of Limerick City and County Council, to the director general of Limerick City and County Council, within 14 days of the notification by the housing authority to the person concerned of the determination under section 10(8). 10
- (3) An appeal under subsection (1) shall be in writing and shall state the ground or grounds on which the appeal is made. 15
- (4) An appeal under subsection (1) may, to support a ground of the appeal, be accompanied by any information relevant to the making of the appeal.
- (5) On receipt by the chief executive or the director general, as the case may be, of an appeal under subsection (1), the chief executive of the authority, or, in the case of Limerick City and County Council, the director general of Limerick City and County Council, shall appoint an officer or employee of the authority to decide the appeal (in this section referred to as an ‘appeals officer’) and shall furnish that person with the appeal. 20 25
- (6) An appeals officer shall be a person who—
- (a) did not make the determination concerned, and
 - (b) is in a more senior role in the authority than the person who made the determination or in a role that is equivalent in seniority to a role that is more senior than the role of that person. 30
- (7) An appeals officer shall be independent in the performance of his or her functions under this section.
- (8) An appeals officer shall decide an appeal under subsection (1) within 14 days of receipt of the appeal and shall—
- (a) confirm the determination concerned, 35
 - (b) vary the determination, or
 - (c) set aside the determination and, where the appeals officer considers it appropriate, make an alternative determination.
- (9) In deciding an appeal under subsection (1), an appeals officer shall consider whether the housing authority acted reasonably and in good faith in making the determination, under section 10(8), that 40

accommodation or lodgings shall no longer be made available to the person.

- (10) A decision of an appeals officer on an appeal under subsection (1) shall be in writing and shall include reasons for the decision.
- (11) An appeals officer shall provide a copy of his or her decision to the person who appealed, under subsection (1), the determination. 5
- (12) A decision of an appeals officer on an appeal under subsection (1) shall be final.”.

PART 3

AMENDMENTS TO HOUSING (MISCELLANEOUS PROVISIONS) ACT 2009 10

Interpretation (*Part 3*)

8. In this Part, “Act of 2009” means the Housing (Miscellaneous Provisions) Act 2009.

Amendment of section 2 of Act of 2009

9. Section 2 of the Act of 2009 is amended, in the definition of “household”, by the substitution of “subject to section 18A” for “subject to sections 20 and 84”. 15

Interpretation (Chapter 3)

10. The Act of 2009 is amended, in Chapter 3 of Part 2, by the insertion of the following section before section 19:

“18A. In this Chapter—

‘habitually resident’ shall be construed in accordance with section 20A; 20

‘household’ means—

- (a) a person who lives alone,
- (b) 2 or more persons who live together, or
- (c) 2 or more persons who do not live together but who, in the opinion of the housing authority concerned, have a reasonable requirement to live together; 25

‘lawfully resident’ shall be construed in accordance with section 20A.”.

Amendment of section 20 of Act of 2009

11. Section 20 of the Act of 2009 is amended—

- (a) by the deletion of subsection (1), and 30
- (b) in subsection (2), by the substitution of “subject to and in accordance with this section, regulations made for the purposes of this section, and section 20A” for “subject to and in accordance with regulations made for the purposes of this section”.

Residency requirements and social housing appeal

12. The Act of 2009 is amended by the insertion of the following sections after section 20:

“Residency requirements

- 20A.** (1) A household shall not be eligible for social housing support unless at the time of carrying out the social housing assessment— 5
- (a) subject to subsection (2), each member of the household is lawfully resident in the State,
 - (b) each member of the household is habitually resident in the State,
 - (c) in the case of—
 - (i) a member of the household who is a person referred to in subsection (3)(c), that member meets the conditions specified in subsections (8), and 10
 - (ii) a member of the household who is a person referred to in subsection (3)(i), that member meets the condition specified in subsection (9) or, where applicable, the condition specified in subsection (10), 15
- and
- (d) no member of the household is subject to a condition that either expressly or by necessary implication prohibits the availing by any such member of social housing support. 20
- (2) Paragraph (a) of subsection (1) shall not apply to a member of a household who is a child (within the meaning of the Children Act 2001).
- (3) For the purposes of subsection (1), a member of a household shall be considered to be lawfully resident in the State where the member is resident in the State and that residency is based on the member being— 25
- (a) an Irish citizen under the Irish Nationality and Citizenship Acts 1956 to 2024,
 - (b) a British citizen within the meaning of section 6A of the Irish Nationality and Citizenship Act 1956, 30
 - (c) a person availing of his or her right under the Regulations of 2015 to enter and reside in the State,
 - (d) a person who has been given a permission to remain in the State under section 49 of the Act of 2015, where the permission concerned is in force, 35
 - (e) a person who is a programme refugee within the meaning of section 59 of the Act of 2015,
 - (f) a person who has been given, or is deemed under the Act of 2026 to have been given, a permission to reside in the State under section 203 of the Act of 2026, where the permission concerned is in force, 40

- (g) a person who has been given, or is deemed under the Act of 2026 to have been given, a permission to reside in the State under section 204 of the Act of 2026, where the permission concerned is in force,
 - (h) a person who has been given, or is deemed under the Act of 2026 to have been given, a permission to enter and reside in the State under section 205 of the Act of 2026, where the permission concerned is in force, or 5
 - (i) a person who is a member of a class of persons prescribed under subsection (4), where the permission concerned is in force.
- (4) For the purposes of subsection (3)(i), the Minister may, in accordance with this section and with the consent of the Minister for Justice, Home Affairs and Migration, prescribe a class or classes of persons, being persons— 10
- (a) to whom such permission (other than a permission referred to in paragraphs (d) to (h) of subsection (3)) as may be specified by the Minister has been given, in accordance with the law of the State, to be or to remain in the State, and 15
 - (b) where considered appropriate, who have been lawfully resident for such period immediately preceding the giving of the permission referred to in paragraph (a), as may be specified by the Minister. 20
- (5) In prescribing a class of persons under subsection (4) (and in specifying a permission under paragraph (a) of that subsection and a period under paragraph (b) of that subsection), the Minister shall consider such matters as, in his or her opinion, are appropriate including the following: 25
- (a) the nature and purpose of the permission given to persons of the class concerned;
 - (b) any condition to which the persons of that class are subject, including—
 - (i) any condition as to duration of stay and engagement in employment, business or a profession in the State, and 30
 - (ii) any condition referred to in subsection (1)(d);
 - (c) where the duration of stay referred to in paragraph (b)(i) is a period of less than two years, any period immediately preceding the permission referred to in paragraph (a) during which that class of persons have been lawfully resident. 35
- (6) The Minister shall not prescribe as a class of persons under subsection (4)—
- (a) a class of persons subject to a condition referred to in subsection (1)(d), 40
 - (b) a class of persons in respect of whom a permission has been given under section 60 of the Act of 2015, or

- (c) a class of persons in respect of whom a permission has been given under section 237 of the Act of 2026.
- (7) For the purposes of subsection (1), a housing authority shall, when determining whether a member of a household is habitually resident in the State, take into consideration all the circumstances of the case, including, in particular, the following:
 - (a) the length and continuity of the member's residence in the State;
 - (b) the length and purpose of any absence, by the member, from the State;
 - (c) the nature and pattern of the member's employment;
 - (d) the member's main centre of interest;
 - (e) the future intentions of the member concerned as they appear from all the circumstances.
- (8) The conditions that apply to a member of a household referred to in subsection (3)(c) are that the member—
 - (a) has been lawfully resident in the State for a period of at least 3 months immediately prior to the day the application for social housing support is made by the household concerned, and
 - (b) is—
 - (i) in employment or self-employed in the State,
 - (ii) a family member (within the meaning of the Regulations of 2015) of a person to whom subparagraph (i) applies, or
 - (iii) a person to whom subparagraph (i) or (ii), as the case may be, no longer applies but who continues to reside in the State in accordance with the Regulations of 2015.
- (9) The condition that applies to a member of a household referred to in subsection (3)(i) is that the member has, on the day the application for social housing support is made, been—
 - (a) lawfully resident for a period, or periods comprising a total, of at least 5 years during the period of 8 years immediately preceding the day the application was made, or
 - (b) lawfully resident for a period, or periods comprising a total, of less than 5 years during the period of 8 years immediately preceding the day the application was made and is, on that day, resident in the State in accordance with a permission specified under subsection (4)(a) that is—
 - (i) in force, and
 - (ii) a permission to reside in the State for a period that enables a person to be, on the date of expiration of that permission, lawfully resident in the State for a period, or periods comprising

a total, of at least 5 years during the 8 years immediately preceding such date of expiration.

- (10) Where a member of a household referred to in subsection (3)(i) is, on the day the application concerned is made, a connected member of another member of the household (including a member of the household referred to in that paragraph (i)) who satisfies subsection (1), the member may, instead of meeting a condition referred to in subsection (9), meet the condition that the member is, on the day the application is made, resident in the State in accordance with a permission specified under subsection (4)(a) that is— 5 10
- (a) in force, and
 - (b) a permission to reside in the State for any period that enables the member to be lawfully resident in the State for a period immediately following such day of application.
- (11) For the purposes of subsection (1), a member of a household shall not be considered to be habitually resident in the State where the member is— 15
- (a) a person who has made an application under Regulation 25 or 26 of the European Union (Subsidiary Protection) Regulations 2013 (S.I. No. 426 of 2013) (in this section referred to as the ‘Subsidiary Protection Regulations’) where the application has yet to be determined under the Subsidiary Protection Regulations, 20
 - (b) a person who has been notified under paragraph (a) of section 3(3) of the Act of 1999 that the Minister for Justice, Home Affairs and Migration proposes to make a deportation order where that notification is in force, whether or not that person has made representations under paragraph (b) of section 3(3) of that Act, where the Minister has not yet made a decision as to whether a deportation order is to be made in respect of such person, 25
 - (c) a person who was an applicant (within the meaning of the Refugee Act 1996) and in relation to whom a deportation order has been made under section 3(1) of the Act of 1999, where the deportation order concerned is in force, 30
 - (d) a person the subject of a deportation order (within the meaning of section 51 of the Act of 2015), where the deportation order is in force, 35
 - (e) a person the subject of a return order (within the meaning of section 51A of the Act of 2015), where the return order is in force,
 - (f) a person the subject of a removal order (within the meaning of Regulation 20(1) of the Regulations of 2015), where the removal order is in force, 40
 - (g) a person the subject of a notification under Regulation 21(1) of the Regulations of 2015, where the notification is in force and the

Minister for Justice, Home Affairs and Migration has not yet made a decision to make a removal order,

(h) a person who—

(i) is an applicant (within the meaning of the Act of 2015), or

(ii) has made, or is deemed under the Act of 2015 to have made, an application under section 15 of that Act which has been refused under section 47 of that Act, 5

(i) a person who has been given permission to reside in the State under section 60 of the Act of 2015, where the permission concerned is in force, 10

(j) a person who—

(i) is, or who is deemed to be, an applicant within the meaning of the Act of 2026, or

(ii) is a person who has made, or is deemed under section 37 of the Act of 2026 to have made, an application under that Act which is the subject of a final decision (within the meaning of that Act) rejecting the application or declaring the application withdrawn, 15

(k) a person the subject of a return decision under Part 11 of the Act of 2026, where the return decision concerned is in force, or

(l) a person who has been given a permission to reside in the State under section 237(8) of the Act of 2026, where the permission concerned is in force. 20

(12) In this section—

‘Act of 1999’ means the Immigration Act 1999;

‘Act of 2010’ means the Civil Partnership and Certain Rights and Obligations of Cohabitants Act 2010; 25

‘Act of 2015’ means the International Protection Act 2015;

‘Act of 2026’ means the International Protection Act 2026;

‘connected member’ means a member of a household referred to in subsection (3)(i) who is one of the following in relation to another member of the household referred to in subsection (3): 30

(a) a spouse of the second-mentioned member;

(b) a civil partner (within the meaning of section 3 of the Act of 2010) of the second-mentioned member;

(c) a cohabitant (within the meaning of section 171 of the Act of 2010) of the second-mentioned member; 35

‘Regulations of 2015’ means the European Communities (Free Movement of Persons) Regulations 2015 (S.I. No. 548 of 2015).

Social housing appeal

- 20B.** (1) Subject to subsection (2), a household may appeal (in this section referred to as a ‘social housing appeal’) a determination made under section 20, or under regulations made under that section, by a housing authority that— 5
- (a) the household is not qualified for social housing support,
 - (b) the household, having previously been determined to be qualified for social housing support, is no longer qualified for such support, or
 - (c) a particular form of social housing support is the appropriate form of such support for that household. 10
- (2) Subsection (1) shall not apply to a household that is in receipt of social housing support.
- (3) A social housing appeal—
- (a) under paragraph (a) or (b) of subsection (1) shall be on one or more of the grounds specified in subsection (4) only, and 15
 - (b) under subsection (1)(c) shall be on one or more of the grounds specified in subsection (5) only.
- (4) The grounds referred to in subsection (3)(a) are that the housing authority was in error in finding that— 20
- (a) the household exceeded the maximum income threshold applicable to the household concerned,
 - (b) the accommodation occupied by the household at the time of carrying out the social housing assessment would meet its housing need, 25
 - (c) alternative accommodation was available to the household that would meet its housing need,
 - (d) the household was not eligible under section 20(5) for social housing support,
 - (e) a member of the household required under paragraph (a) of section 20A(1) to be lawfully resident was not so lawfully resident, 30
 - (f) a member of the household required under paragraph (b) of section 20A(1) to be habitually resident was not so habitually resident,
 - (g) a member of the household required under paragraph (c) of section 20A(1) to meet a condition specified in that section did not meet that condition, or 35
 - (h) a condition specified in section 20A applied to a member of the household.

- (5) The grounds referred to in subsection (3)(b) are that the housing authority was in error in—
- (a) not taking into account social housing support that was previously provided by a housing authority or was in error in relation to the social housing support that was taken into account, 5
 - (b) its description and classification of the household's need,
 - (c) its description of the household's specific accommodation requirements according to a particular category of household need, or
 - (d) its description of the household's accommodation need based on the composition of the household. 10
- (6) A social housing appeal shall be made to the chief executive of the housing authority concerned within 14 days of the notification by the housing authority to the household concerned of the making of a determination in respect of the application for social housing support concerned under section 20. 15
- (7) A social housing appeal shall be in writing and shall—
- (a) state whether the appeal is an appeal under paragraph (a), (b) or (c) of subsection (1), and
 - (b) state the ground or grounds on which the appeal is made. 20
- (8) A social housing appeal may, to support a ground of the appeal, be accompanied by any information previously provided to the housing authority concerned for the purpose of making the determination the subject of the appeal.
- (9) On receipt by a housing authority of a social housing appeal made in accordance with this section, the chief executive of the authority shall appoint an officer or employee of the authority to decide the appeal (in this section referred to as an 'appeals officer') and furnish that person with the social housing appeal. 25
- (10) An appeals officer shall be a person who— 30
- (a) did not make the determination concerned, and
 - (b) is in a more senior role in the authority than the person who made the determination or in a role that is equivalent in seniority to a role that is more senior than the role of the person who made the determination. 35
- (11) An appeals officer shall be independent in the performance of his or her functions under this section.
- (12) An appeals officer—
- (a) shall decide a social housing appeal within 28 days of receipt of the social housing appeal under subsection (9), and 40

- (b) shall—
 - (i) confirm the determination concerned,
 - (ii) vary the determination, or
 - (iii) set aside the determination and, where the appeals officer considers it appropriate, make an alternative determination. 5
- (13) In deciding a social housing appeal, an appeals officer shall consider—
 - (a) all information provided by the household to the housing authority for the purpose of making the determination the subject of the appeal, 10
 - (b) the social housing appeal, and
 - (c) any accompanying information provided in accordance with subsection (8).
- (14) A decision of an appeals officer on a social housing appeal shall be in writing and shall include reasons for the decision. 15
- (15) Where an appeals officer makes a decision on a social housing appeal under subparagraph (ii) or (iii) of subsection (12)(b), the date of the decision shall be deemed to be the date of the determination.
- (16) An appeals officer shall notify the household concerned of his or her decision on the social housing appeal concerned. 20
- (17) A decision of an appeals officer on a social housing appeal shall be final.”.

Amendment of section 38 of Act of 2009

Transitional provisions

 - (a) an application for social housing support where, before the coming into operation of *section 12*, the housing authority concerned has not yet determined the application, 30
 - (b) a review in accordance with regulations made under section 20 of the Act of 2009 of a social housing assessment where, before the coming into operation of *section 12*, the housing authority has not yet concluded the review, and 35
 - (c) a summary under section 21 of the Act of 2009 where, before the coming into operation of *section 12*, the housing authority has not yet completed the summary.

- (2) The housing authority may give notice in writing to the household to which an application, a review or a summary, referred to in *subsection (1)* relates—
 - (a) stating that the household shall complete and submit to the housing authority a form prescribed by the Minister for the purposes of demonstrating that each member of the household satisfies paragraphs (b) and (d) and, where applicable, paragraph (c), of section 20A(1) of the Act of 2009, and 5
 - (b) specifying a period of not less than 21 days from the date of the notice within which the form shall be submitted to the housing authority.
- (3) The housing authority may, where it considers it appropriate to do so, extend the period referred to in *subsection (2)(b)*. 10
- (4) The Minister may prescribe a form for the purposes of *subsection (2)* and, in so prescribing, may prescribe the information and particulars to be provided by a household in that form and verification to be provided by the household of such information and particulars.
- (5) A housing authority shall, in determining an application, concluding a review or completing a summary, referred to in *subsection (1)*, take into consideration information submitted in accordance with a notice given under this section. 15
- (6) A person is guilty of an offence and is liable on summary conviction to a fine not exceeding €2,000 where he or she is a member of a household to which a notice is given under this section and, in purported compliance with that notice, the person— 20
 - (a) knowingly makes any statement or representation which is to his or her knowledge false or misleading in any material respect, or knowingly conceals any material fact, or
 - (b) furnishes, or causes or knowingly allows to be furnished, any information which he or she knows to be false in a material particular. 25
- (7) An offence under *subsection (6)* may be prosecuted by the housing authority who gave the notice under this section to the household referred to in that subsection.

(II) owned by that landlord.”.

Amendment of section 4 of Act of 2004

the Board shall serve a further notice on the landlord stating that the landlord is required to give to the Board, in writing, the information referred to in subsection (6), that the Board’s opinion has not altered

- and that, if the landlord fails to do so within 14 days from the receipt by the landlord of the notice, the landlord shall be guilty of an offence.
- (10) A landlord who fails to comply with a notice under subsection (9) within 14 days from the receipt by the landlord of the notice shall be guilty of an offence. 5
- (11) Where the Board has reasonable grounds for believing that a person has committed an offence under subsection (10), it may serve on the person a notice in the prescribed form (in this section referred to as a ‘fixed payment notice’) stating that—
- (a) the person is alleged to have committed an offence under subsection (10) (in this section referred to as the ‘alleged offence’), 10
- (b) the person may, during the period of 28 days beginning on the date of the fixed payment notice, make to the Board a payment of €100 or such greater amount not exceeding €500 as may be prescribed, identifying the notice to which the payment relates, 15
- (c) the person is not obliged to make the payment specified in the notice,
- (d) a prosecution of the person in respect of the alleged offence will not be instituted during the period of 28 days beginning on the date of the notice, and 20
- (e) if the payment specified in the notice is made during that period, no prosecution in respect of the alleged offence will be instituted.
- (12) Where a fixed payment notice is served—
- (a) the person to whom it applies may make a payment in accordance with subsection (11)(b), 25
- (b) the Board shall, upon receipt of the payment, issue a receipt for it,
- (c) any payment received by the Board shall not be recoverable by the person who made it, and
- (d) a prosecution in respect of the alleged offence shall not be instituted during the period specified in subsection (11)(b) and, if payment so specified is made during that period, no prosecution in respect of the alleged offence shall be instituted. 30
- (13) In proceedings for an alleged offence, it shall be a defence for the defendant to prove that the defendant has made a payment in accordance with subsection (11)(b) pursuant to a fixed payment notice served in respect of the alleged offence. 35
- (14) Payments received by the Board under this section shall be paid into or disposed of for the benefit of the Exchequer.”.

(7) A landlord who fails to comply with a notice under subsection (6) within 14 days from the receipt by the landlord of the notice shall be guilty of an offence.”.

 - (d) a prosecution of the person in respect of the alleged offence will not be instituted during the period of 28 days beginning on the date of the notice, and
 - (e) if the payment specified in the notice is made during that period, no prosecution in respect of the alleged offence will be instituted. 20
- (2) Where a fixed payment notice is served—
- (a) the person to whom it applies may make a payment in accordance with subsection (1)(b),
 - (b) the Board shall, upon receipt of the payment, issue a receipt for it,
 - (c) any payment received by the Board shall not be recoverable by the person who made it, and 25
 - (d) a prosecution in respect of the alleged offence shall not be instituted during the period specified in subsection (1)(b) and, if payment so specified is made during that period, no prosecution in respect of the alleged offence shall be instituted. 30
- (3) In proceedings for an alleged offence, it shall be a defence for the defendant to prove that the defendant has made a payment in accordance with subsection (1)(b) pursuant to a fixed payment notice served in respect of the alleged offence.
- (4) The Minister may prescribe different amounts for different offences for the purposes of subsection (1). 35
- (5) Payments received by the Board under this section shall be paid into or disposed of for the benefit of the Exchequer.
- (6) In this section, ‘relevant offence’ means an offence under section 19(6G) or 22(7).” 40

- (10) In proceedings for an alleged offence, it shall be a defence for the defendant to prove that the defendant has made a payment in accordance with subsection (8)(b) pursuant to a fixed payment notice served in respect of the alleged offence. 15
- (11) Payments received by the Board under this section shall be paid into or disposed of for the benefit of the Exchequer.”.

- (6) Where a fixed payment notice is served—
 - (a) the person to whom it applies may make a payment in accordance with subsection (5)(b),
 - (b) the Board shall, upon receipt of the payment, issue a receipt for it,
 - (c) any payment received by the Board shall not be recoverable by the person who made it, and 10
 - (d) a prosecution in respect of the alleged offence shall not be instituted during the period specified in subsection (5)(b) and, if payment so specified is made during that period, no prosecution in respect of the alleged offence shall be instituted. 15
- (7) In proceedings for an alleged offence, it shall be a defence for the defendant to prove that the defendant has made a payment in accordance with subsection (5)(b) pursuant to a fixed payment notice served in respect of the alleged offence.
- (8) Payments received by the Board under this section shall be paid into or disposed of for the benefit of the Exchequer.”. 20

- (1B) A judge of the District Court, if satisfied on the sworn information of a person referred to in subsection (1) that— 10
 - (a) there are reasonable grounds for suspecting that any information or records, as the said person may reasonably require for the purposes of the said person's authorisation under this section, is or are held on any premises or any part of any premises, and
 - (b) the said person, acting under authority for the purposes of this section, has been prevented from entering the premises or any part thereof, 15

may issue a warrant authorising a person authorised in writing by the Board for the purposes of this section, accompanied if necessary by other persons, at any time or times within 30 days from the date of issue of the warrant and on production if so requested of the warrant, to enter, if need be by reasonable force, the premises or part of the premises concerned for the purposes of this section. 20
- (1C) An application for a warrant under subsection (1B) shall be made to a judge of the District Court for the time being assigned to the District Court District within which the premises in respect of which the application is made is situated.”, 25
- (b) by the substitution of the following for subsection (2):
 - “(2) A person shall not be authorised under subsection (1) unless the Board has reasonable grounds for believing that there has been a failure to comply with section 134 in respect of the dwelling concerned.”, 30
- and
- (c) in subsection (4), by the insertion of “, or ought to have been,” after “ought to be”.
