Further to my attendance at the meeting of the Committee of Public Accounts on Tuesday 23
October 2012 and to Niamh Maguire's letter dated 30 October 2012, I attach documentation for the Committee's information outlining:-

A breakdown of Deputies Ministers and Senators who are availing of the unvouched allowances payments and the amounts paid in these categories in 2011. Please note that the breakdown of Deputies, Ministers and Senators availing of the unvouched allowances are the current (2012) figures and the 2011 amounts paid are in respect of both the pre-election and post-election period in 2011.

A note on the costs of allowances paid to members on Committees

A note outlining the number of Members who have claimed a grant for a constituency office and who are also availing of extra accommodation for their staff in Leinster House.

Members also requested information in relation to the allowance paid to Commission Members. Each Member of the Houses of the Oireachtas Commission receives an allowance of €9,500 per annum. It is expected that total payments for 2012 will be in the region of €76,000.

For the convenience of the Committee members, a table is also included below that sets out the information requested in a user-friendly format.

I would also like to take this opportunity to clarify, for the information of the Committee, the position in relation to the increase in the leaders' allowance which was granted in 1996. When reading the transcript of the PAC meeting of 23rd October, I obviously misread a question by Deputy Eoghan Murphy on the *independent* Leaders' Allowance and replied in the context of the overall increase of the Allowance to all parties in 1996 which was significant. The allowance for independents was commenced in that 1996 legislation and was not obviously the subject of the increase. The allowance was set at €10,000 at that stage.

Question 2 - Cost of allowances paid to members on Committees:

The total cost of allowances for Committees for 2012 (excluding entertainment allowance – see note below) is €130,900.

This is made up of:

Payments to the Chairs of Joint Committees for 2012 will be €114,000. This consists of €9,500 paid to 12 Chairpersons which is paid in equal amounts during the year.

There is one payment for the Chair of the Select Committee on Members' Interests of Seanad Éireann amounting to €3,100 in 2012.

Chairpersons also receive an additional telephone allowance of €1,100 annually, although the Chair of the PAC receives €1,700. The estimated total payment in respect of Committee Chairs telephone allowance is €13,800.

NOTE: The Committee entertainment allowance not included, but spend as of October 2012 was €5,565.30. The total amount spent in 2011 was €8,616.98. The estimated expenditure for both years was significantly higher (€40k for 2011 and €25k for 2012). It is a matter for each Committee to decide how much is spent in relation to this and the amounts vary considerably.

Question 3 - Number of members who have claimed a grant for a Constituency Office

Of the 166 members in the current Dáil, the number of Members who have claimed a grant for a constituency office (commonly known as COG) is 121 (70 of whom claimed the grant prior to the 31st Dáil. These Offices may or may not still be in use). The cost of these claims is €341.406.90.

The number of Members who have claimed COG and also are recorded as having staff based in Leinster House is 57. It should be noted, however, that some of these TDs may be using the same staff in both their constituency and in Leinster House and the staff member's working weeks may be split between each location.
