

2. Details of the lease arrangements for Marine House between July 2003 and May 2006

The Marine House property was unoccupied in the period 2003 to 2006. The BAI actively marketed the premises during that time period (via Lisney) but were unsuccessful in finding a tenant until mid to end 2005 when a prospective tenant was sourced. The negotiations on the lease took a number of months and the premises were sub-let to Brindley Advertising from May 2006.





A breakdown of the 'Debtors' figure of €676,000 which was recorded under Point 6
 'Debtors' on the BAI notes to the Financial Statements for the year ended 31st December 2011

The Debtors figure is, as outlined below, primarily composed of levy debts owed by broadcasters to BAI (€655,282), in addition to rental income due (€20,576) and a small outstanding application fee (€42).

4. A breakdown of the list of broadcasting contractors considered to be levy debtors

The levy model is such that broadcasters pay differential amounts of levy dependent on their qualifying income in any year and the BAI's costs in that year. Smaller services such as the majority of community, institutional and temporary radio services pay a de minimis charge of €950. Invoicing of levy occurs quarterly with the last invoice of the year being issued on December 1st. Escalation procedures are in place to manage outstanding debts. Of the levy debtors amount of €655,280 as of December 31st, 2011, only €8,300 remains outstanding. The majority of this debt relates to temporary and institutional services, some of which are no longer broadcasting.

5. Support for women in media

The BAI undertook to provide information regarding its support of initiatives which promote women's participation in the media. The BAI has awarded a sponsorship grant of €5,000 to the Women On Air organisation to host a conference later this year on gender representation in news and current affairs broadcasting. The conference aims to raise awareness of the issues surrounding women's representation as well as to present research findings in this area and work with industry leaders to identify practical steps which might be taken in the future to address these issues.

The BAI has also contributed funding towards a study being carried out by the European Institute for Gender Equality. The research, which is being carried out at the request of the Irish Government as part of the Irish Presidency of the EU will focus on women in decision making in the media and the participation of women in programming. The BAI funding has enabled the inclusion of Irish radio in the research. It is believed the research will be particularly relevant to Ireland given the high levels of radio listenership and current affairs and news programming. The research will build on previous snapshot research carried out by the National Women's Council of Ireland and will be presented at the Women On Air conference in September of this year.
