Re PAC Meeting 11th December 2013

Dear Mr Mc Guinness

I have been in contact with Mr McEnery over the past few months in relation to obtaining clarification to be placed on the public record regarding the position of IT Manager as being the incorrect title of the person who receives top-ups in the Central Remedial Clinic. The correct title of the person who receives the top ups is "Senior Manager, Technology, Communications, Research & Development"

The previous chairman Jim Nugent was to have brought this clarification to the PAC meeting of the 11th December 2013, but failed to do so. In phone conversations after the meeting with Mr McEnery I was assured that the matter would be dealt with by means of publication of correspondence received from the CRC to the PAC on this matter, which Mr McEnery stated he had received. This never materialised. After Christmas I was further assured by Mr McEnery in another call to his office that the issue would be dealt with during the meeting of 16th January 2014, However no clarification has been made.

The problem I have is that whilst this controversy continues to evolve in a manner which no-one can predict this inaccurate information remains on the public record. I require a means to be able to instance the public record should this inaccuracy cause me difficulty in the future such as job applications etc.

I trust that this situation will be rectified by the inaccuracy being placed in the public record. This could either be done by publishing the correspondence from the CRC to the PAC or a mention at the commencement of the next PAC meeting.

I appreciate that you are probably inundated with work at the moment, but this is very easy to rectify. I have attached a number of emails to support the situation as outlined above.
