Supply of follow-on information arising from PAC hearing of 15 May 2014

Dear Ms. Falsey,

I refer to the Secretariat's letter of 26th May 2014 concerning information I undertook to supply to the Committee during the course of the hearing on 15th May 2014. In my response of 10th June 2014 I indicated that I would supply the Committee with further information in relation to various VEC/ETB issues as soon as the material could be collated. I apologise for the delay in forwarding the remainder of the follow on material.

I now attach the following information:

1. Co. Cork VEC/City of Cork VEC and Cork Institute of Technology (CIT)

Please see at Appendix 1-Worksheets 1 to 4 inclusive:

- details of persons who were members of both the VECs and the board of CIT;
- the number of board meetings of the VECs;
- payments to VEC committee members and the length of service of Committee members.
- payments to the Cork Institute of Technology Governing Body members

Please note that the information in relation to payments to the VEC Committee members and their length of service relates to those persons who were members of the last Co. Cork and City of Cork VEC Committees, which were in existence from 2009 to 2013. A number of these persons had previously been members of earlier VEC Committees, which were replaced by

Education and Training Boards on 1st July 2013, and this is reflected in the information on their total period as members of the respective VECs. For such persons, the payment figures include amounts paid to them in 2009 in respect of their membership of the previous VEC. Similarly, the payment figures include amounts paid in the calendar year 2013 to those persons who were also members of the first Board of Cork ETB in the period 1 July 2013 to 31st December 2013.

The amounts paid to VEC members included travel and subsistence and, in certain cases, interview board fees.

In regard to the Governing Body of the Cork Institute of Technology the payment figures identify the travel and subsistence costs paid to them, as well as sum paid in relation to interview board fees, for the period 2009 to 2013. The details of CIT Board membership and the capacity in which members were appointed were supplied in my June 2014 response to the Committee.

2. Co. Wexford VEC - Lease on Iberius House

Clarification was sought from Waterford and Wexford ETB in relation to specific queries raised by the Public Accounts Committee regarding the lease of Co. Wexford VEC's former head office, Iberius House. This information is set out below:

(a) Lease of Iberius House

Co. Wexford VEC entered into a 30 year lease for Iberius House in 1984. A second lease for additional office space at the same location was signed in 1998.

The total rent for Iberius House was €67,465 per annum. The Chief Executive of Waterford and Wexford ETB, who was the former CEO of Co. Wexford VEC, but not at the time the leases were entered into, did not have information as to how the rate was negotiated. The VEC also incurred the cost of car parking at the premises, which was €36,000 approximately in 2006. Both leases expired during late October 2014 and the VEC stopped incurring the cost of car parking in 2006.

(b) Annual rent obtained by Co. Wexford VEC for Iberius House

Co. Wexford VEC sublet Iberius House from July 2006 to June 2008 at an annual rent of €51,000. Subsequently, one floor of the premises was sublet for €7,000 per annum. The ETB advises that because of the economic situation since 2008, the VEC was unable to realise any appreciable value from the premises.

(c) Rationale for re-locating the VEC's Head Office

The Department has been informed by the ETB that in 2005 a review was carried out by management of the fitness for purpose of Iberius House. At that time there were over 30 staff members working in the building, space was very limited, staff facilities very poor and certain senior officials were obliged to share office space.

I understand from the ETB that there were no meeting room facilities in Iberius House, and that meetings/interviews usually had to be held off premises with

consequential costs attaching. The ETB advises that the VEC Committee meetings had to be held in the Co. Council chamber, and space was at such a premium that the CEO had to vacate his/her office in order to give visiting auditors space to work. The former offices were not accessible to persons with a disability nor were there toilet facilities for such persons. Security in the building was poor, the front door opened onto the street, and the stairs and lift were easily accessible to passers-by. The ETB has also informed the Department that the fabric of the building and its décor were in a poor condition and that the VEC were rapidly running out of space for filing and storing records

The ETB also advises that rental costs for car parking were escalating, and in 2005 were of the order of €36,000. Together with the rent for Iberius House this brought the cost of Co. Wexford VEC's head office facilities to €103,476. At this time the VEC had also looked at renting additional space to accommodate adult education staff. Rental costs for this were being quoted in the region of €50,000 to €60,000 per annum. This would have led to total costs of approximately €164,000 annually, without taking into account the cost of fitting out new offices for adult education, providing I.T. facilities, security, cleaning etc. for an additional premises.

I understand that the VEC was also assured by local estate agents that there would be no problem sub-letting the premises, as they were located in the town centre where there was a high demand for office accommodation.

(d) Move to Ardcavan premises

Accordingly, the VEC decided to investigate the feasibility of moving from the town centre to purpose built accommodation on the outskirts of the town, to include meeting rooms, training rooms for adult and continuing education and sufficient car parking facilities for staff, learners and visitors. Subsequently, the VEC moved to its new premises in Ardcavan, Wexford in July 2006. The annual rent of these premises is €186,000 approximately. In addition there is an annual contribution to the landlord of €3,500 for buildings insurance and a €1,800 service charge. Fit out costs of €131,000 were met from the VEC's own resources

4. Cork ETB – Legal Matters

Please see at Appendix 1- Worksheet 6, details of the human resource cases in Co. Cork VEC/ Cork ETB from 2009 to date.

It should be noted that human resource cases are a matter for the ETB as the employer in the first instance. The Committee is asked to note that with some 3,600 employees, Cork ETB is the largest employer in the ETB sector and it is the view of the Department that some level of employee related cases will always be likely in an organisation of this size.
