Combined liability of the Universities

In 2014/15 the combined liabilities i.e. bank overdrafts and loans, of the seven universities was approximately €315m. A substantial part of this is made up of loans from the European Investment Bank at competitive rates to finance infrastructural projects including Purpose Built Student Accommodation (PBSA). These loans are arranged over periods of usually 25-30 years.
