Dear Mr. Lenihan

I refer to my attendance at the meeting of the Committee on 22 March 2018 and to the conduct of that meeting.

I am acutely conscious and respectful of the critical role which the Public Accounts Committee plays in ensuring efficient and effective use of the public's money. As an Accounting officer, I regard my personal accountability to the PAC is a matter of the utmost seriousness. This is reflected in the extent of preparation which I undertake for my appearances as a witness and also the degree to which I am personally involved in ensuring that comprehensive follow-up information is expeditiously provided by my Department.

In that context, there is one particular area of interaction at the meeting that I would like to refer you to.

Deputy MacSharry stated that in May 2014, "the then Chairman of the Committee of Public Accounts asked Mr. Ó Foghlú what qualifications a contract manager should have and what qualifications the contract manager in this case actually had. Mr. Ó Foghlú said he was not aware of the details but that he would get them. I have checked through the records and he did not come back to the committee." I said that I would check and he further stated that "to the best of my research, Mr. Ó Foghlú did not come back". I responded that "I have a system in place to make sure we come back on every follow-up but I may have made a mistake." Deputy MacSharry then said that "Maybe it was a mid-term approach", seeming to reference in a mocking manner earlier responses by me on a different matter and I indicated that it was unfair. At the lunch break I received confirmation from my office of the date on which I responded to the committee on this matter and provided this information to you. The Chairman noted this at the end of the meeting.

In the continuing dialogue with Deputy MacSharry he said that "I know from other engagements here, and we will be going back to them directly, that CIT has a history of lavish parties. Was Mr. Ó Foghlú at the retirement party for this individual?" He repeated the question again. The Chairman asked me not to answer. The Chairman also indicated on a number of occasions that the line of questioning was not relevant to the subject matter for the meeting. I indicated that there could be an insinuation being made by the Deputy.

You will appreciate that I have significant experience of attending the committee as a witness. I expect to receive challenging and robust interrogation on matters related to the issues before the Committee, but I do not expect to be treated unfairly or to be the subject of unfair and unwarranted insinuation. I consider that Deputy MacSharry's manner of asking the question was unfair and could, to any reasonable member of society watching proceedings, injure my professional reputation.

I am therefore seeking to highlight what I believe was unfair treatment of me as an invited witness to the committee.

I would suggest that Deputy MacSharry might now acknowledge that his comments regarding my alleged non-response to queries regarding qualifications for a particular post at a meeting held almost 4 years ago were misleading and untrue and that his question regarding my attendance at a putative retirement party was also unwarranted. I think this would send a strong signal that the high standards set out in the committee's own protocols for witnesses are consistently adhered to, namely that "you have confidence [as a witness] that you will be treated fairly, with respect and consideration and that your evidence will be assessed on its merits alone".

I would also like to request that you would ensure that at future meetings I am not placed in an unfair position again. I would be happy to meet you and the Chairman to discuss how this might be achieved.
