### Note

Purchases were made locally through 25 school book companies in 2016. Schools and Centres sought value for money at local level however in the aggregate KWETB were non compliant. There was no OGP framework for the procurement of school books in 2016. The OGP ran a national tender for school books during 2017. KWETB have used this framework and ran a mini competition to appoint a single supplier of school books in 2018.

#### Note

Because of moratorium on recruitment since 2009 staff could only be replaced using recruitment agencies. In 2012 a small number of staff were temporarily recruited. The numbers of staff recruited grew and through aggregation of costs the need for a tendering competition became apparent. A tendering competition commenced in 2018 and is now in place.

#### Note

An ICT Managed Service Contract and On-site Technical Support Contract were put in place following a tender process in 2012/13. These contracts expired in 2016, were not renewed and instead rolled over due to the expectation of a sectoral solution, development of a comprehensive and integrated KWETB ICT Strategy, critical need to ensure continuity of vital services in our schools and centres, and IT resource challenges in KWETB. KWETB currently have developed an ICT Strategy and have progressed the development of an RFT for these services. We expect to be compliant by Q1 2020

### **Items Purchased at Auction**

#### Note:

Items were purchased at seven auctions including catering equipment - €24k of which we estimate 20% was used. racking and pallets - €45k of which we estimate 15 to 20% was used and computers - 85k which were all used. Office furniture and Garden equipment - €16.5k. Some items of catering equipment, racking and furniture remain in storage and KWETB are currently investigating ways of disposing of same.

The practice of purchasing goods at auction was the sole practice of the then CE and no longer occurs in KWETB.

#### **Cleaning Services**

#### Note

Cleaning Services tender awarded in 2014. Not all existing schools/centres moved to new conract for all services. Two schools were non compliant. This contract has now concluded and we are engaging with the schools/centres involved with a view to run a new tender.

## **Catering Services**

A previous tendering process took place in the school several years previouly which had expired however the service continued. This was regularised by tender process and contract now in place since 20/11/2017.
