Many thanks for your letter, please find the response to the queries raised by the Committee members.

 The Board of Caranua appointed Ms Rachel Downes to the position of Acting Chief Executive Officer (Principal Officer, Pt 1) on 17th October 2017. Rachel Downes had been employed as the Director of Services (Assistant Principal, Pt 3). The Chief Executive Officer was in receipt of a salary until 24th January 2018.

Between 17th October – 24th January, Ms Downes received an acting up allowance of €3,745.91.

In order to protect the confidentiality of Survivors, the majority of funding support
payments are made via third-party cheque. The Survivor can choose to receive the
cheques for personal distribution to the supplier or for the cheque to be sent directly
to the supplier.

The supplier of the third-party cheques reissued €904,269 to Caranua for cheques which expired between 2014 – 2018.

In addition, each year Caranua processes, cancels and reissues a number of cheques. The majority of these cheques are reissued to the Survivor. The most common reasons are as follows.

- · Change of supplier
- Application withdrawn
- · Change in amount due to discount
- Cheque expired (notified by Survivor)
- · Cheques not accepted by supplier

- The 2018 draft Financial Statements were presented to the Board of Caranua on 26th February 2019 and were then submitted to the Department of Education and Skills and the Office of the Comptroller & Auditor General on 28th February 2019.
- 4. Caranua submitted a business case to the Department of Education and Skills for approval for additional staffing in order to improve the service offer and waiting times for Survivors. Sanction was received in April 2016 for 14 additional staff members. An external agency was sourced to support the recruitment company process, which included advertising the roles, shortlisting the 527 applications received, plan and organise rounds of interviews, participate on the interview panel and then reference check the successful candidates. There was a cost of €65,550 plus VAT of €15,076.50.

- 6. Caranua are working with 317 Survivors who applied prior to 1st August 2018. 98.5% of these Survivors are working with Caranua on their initial application. At this time, these Survivors each have received an average of five funding support payments and an average of €6,955 in funding supports. These averages will increase as applications continue to progress. The highest funding supports provided are €42,020. The longest an application has been open is since June 2014. As was explained at the committee meeting there are a number of reasons why an application could be open for this length of time, such as ill health, homelessness or incarceration.
- 7. Section 29 of the RISF Act 2012 provides for Caranua's funding. That section includes for four elements:
 - 1(a) total moneys received from congregations and placed in a Central Bank account these covered contributions made in the period from 2010 to the establishment of Caranua in March 2013. €40m received.
 - 1(b) the aggregate of interest earned on the funds during the period referred to in 1(a) was €282,904.45
 - 2(a) moneys received as a contribution from charitable trusts (i.e. congregations) towards Caranua (and made following enactment of the legislation). €61,591,273.06 received.
 - 2(b) the aggregate of interest earned by congregations on the funds referred to in 2(a) prior to enactment of the legislation was €1,099,106.76

In summary, there was €1.382m interest earned on funds deposited prior to transfer to the NTMA for use by Caranua, which is in addition to the €110m.

Separate to the above, €321,479 in accumulated interest was earned by the fund since Caranua commenced operations until 31st December 2017.

8. Caranua currently employs 19 staff, 17 are on fixed term or specified purpose contracts, two are temporary agency staff. At the time of closure staff who have worked in Caranua for a period of two years or longer will be entitled to statutory redundancy under the Redundancy Payments Acts 1967–2014. An estimated €38,000 will be required for redundancy payments.



Caranua operates a freephone service for callers from Ireland and the UK. In May 2018, a
new telephone system was installed. The following are statistics of incoming and outgoing
calls for that period. Our telephone system does not differentiate between open and
closed callers.

10. As per the Residential Institutions Statutory Fund Act, all administration costs must be met from the fund. The Board of Caranua and management have worked determinedly to minimise operational costs and continue to do so during the wind down phase. As there is no additional funding available to Caranua, we have to operate within the funding available across all areas of our work. The next section sets out the breakdown of administration costs to 2017. As of 1st October 2019, it is projected that €1,306,500 will be required to continue the operations of Caranua until 30th June 2020.

- *Included in Administration Costs is an amount of €73,600 representing amounts that the Minister has requested to be drawn down from the Investment Account to make payments to the Appeals Officer under Section 31(3) of the Act.
- 12. Caranua has received feedback from a very small number of Survivors who are dissatisfied with works carried out in their homes by a particular company. Caranua met with the company involved to discuss the concerns raised, the company has requested time to review the complaints and revert back to the Survivors and Caranua in relation to next steps. Caranua remain in contact with the company at this time.

During the course of the Committee meeting, a discussion took place in relation to legal cases. To clarify some points made, a High Court case was taken against the independent Appeals Officer in relation to a decision made on an appeal regarding the implementation of the limit of €15,000. Due to the subject matter of this case, Caranua sought to be joined as a notice party. On 28th May 2019, a High Court judgment was made which dismissed the appeal in relation to the limit of €15,000 and affirmed the decision of the Appeals Officer to uphold the decision of Caranua in relation to the implementation of a limit to enable a greater number of Survivors to avail of services.

As discussed at the Committee meeting, Caranua has received applications from 6,543 individuals, of these 5,987 were Survivors who were eligible to apply for funding supports. By the end of September 2019, Caranua has provided over 54,000 individual funding supports payments to 5,695 Survivors to the value of €91.3M.

Caranua works with Survivors who require long-term supports and we also know that there are eligible Survivors who have not availed of funding supports. Caranua would fully support the implementation of additional legislation to provide future funding support to Survivors.
