### **Introduction -**

This is the contribution of the Joint Committee on Housing, Planning and Local Government in response to the motion passed by both Dáil Éireann and Seanad Éireann on 3<sup>rd</sup> October 2017 in relation to the Draft National Planning Framework – Ireland 2040: Our Plan.

# The motion passed by the Houses;

- requests the Joint Committee on Housing, Planning and Local Government to collate and submit any observations or recommendations during this final consultation period for consideration by the Government, with the approval of the Committee on behalf of both Houses of the Oireachtas for the proposed strategy of the draft National Planning Framework;

The Joint Committee engaged with Mr. Eoghan Murphy, T.D., Minister for Housing, Planning and Local Government, Mr. Damien English T.D., Minister of State for Housing and Urban Development and officials from the Department on 18<sup>th</sup> October 2017 in relation to the Draft National Planning Framework. Following this engagement, the Committee has agreed the following observations and recommendations on the Draft National Planning Framework.

Deputy Eoin Ó'Broin, formally dissents to the observations and recommendations contained in this contribution.

### Observations and Recommendations of the Joint Committee -

- The Committee recommends an extension of the public consultation by one month. An extensive advertising campaign should be undertaken to highlight this fact;
- The Committee is broadly supportive of the Draft National Planning Framework Ireland 2040:Our Plan (the Plan);
- the Committee is concerned that no detail has been provided in relation to the Capital Investment Plan due for publication in tandem with the National Planning Framework. The Committee believe that greater transparency and engagement is needed in relation to the Capital Investment Plan;
- the Committee believe that effective land management, in particular land controlled by State agencies, is a crucial factor for the implementation of the Plan;

- the Committee believe that the Plan should have greater emphasis towards sustainable public transport;
- the Committee recommend that public transport providers be required to increase coordination in the delivery of their services;
- the Committee believe that the Plan should be future proofed for advancements in technology, specifically providing for a mechanism for the inclusion of technological innovation in planning matters;
- the Committee believe that greater emphasis be placed within the Plan on the critical infrastructure needed to allow towns and villages to develop;
- the Committee believe that a clear mechanism be developed for the redesignation of towns and villages if they change in population size. In particular the Plan has to be dynamic to take account of demographic changes;
- the Committee believe that greater emphasis be provided to the establishment of Technological Universities within the Plan;
- the Committee believe that greater emphasis should be given to increasing Ireland's energy security within the Plan with indigenous renewable energy sources given greater priority;
- the Committee believe that greater emphasis should be provided within the Plan to urban renewal and the re-adaption of older homes to suit modern living needs;
- the Committee believe that Figure 7.2 Areas for Cross-Border Local Coordination, Co-Ordinated Spatial Planning be amended to read "Develop the critical mass of the Newry-Dundalk-Drogheda area to compete with other larger cities", and/or the creation of Drogheda as a city.
- the Committee believe that the inclusion of measureable targets and annual progress reports be included in the Plan as a form of accountability to the Houses of the Oireachtas.

# **Conclusion -**

The Committee request that the observations and recommendations as outlined in this contribution be taken into account in the final draft of the National Planning Framework.
