### **Wednesday proposal no. 5 - Statements on the Environmental Protection Agency Water Quality Report 2022**

- The Statements on the Environmental Protection Agency Water Quality Report 2022 shall not exceed 145 minutes, with arrangements in accordance with those agreed by Order of the Dáil of 30<sup>th</sup> July, 2020, for 135 minutes, following which a Minister or Minister of State shall be called upon to make a statement in reply which shall not exceed 10 minutes, and members may share time

### **Wednesday proposal no. 7 - Courts and Civil Law (Miscellaneous Provisions) Bill 2022**
