 - (iii) members may share time

Wednesday proposal no. 1 - Arrangements for business

- The ordinary routine of business as contained in Schedule 3 to Standing Orders shall be modified to the following extent:
 - (i) in the event the Taoiseach is unable to attend for questions pursuant to Standing Order 46(1), the SOS pursuant to Standing Order 25(1) may take place earlier than

- (ii) the weekly division time may be taken earlier than 8.45 p.m., and shall in any event be taken on the adjournment of proceedings on the amendments from the Seanad to the Local Government (Mayor of Limerick) and Miscellaneous Provisions Bill 2023 [*changed from* Local Government (Mayor of Limerick) Bill 2023], or where those proceedings conclude within the allotted time, on the conclusion thereof, with consequential effect on the time for the adjournment of the Dáil

Wednesday proposal no. 2 - Protection of Employees (Trade Union Subscriptions) Bill 2024

- Notwithstanding anything in Standing Order 170(2), the proceedings on Second Stage of the Protection of Employees (Trade Union Subscriptions) Bill 2024 shall, if not previously concluded, be brought to a conclusion after two hours

Wednesday proposal no. 2 - Motion re proposal for a Regulation establishing an EU Talent Pool

 - (ii) members may share time

Wednesday proposal no. 3 - Forty-first Amendment of the Constitution (Agreement on a Unified Patent Court) Bill 2024

- The proceedings on Second Stage of the Forty-first Amendment of the Constitution (Agreement on a Unified Patent Court) Bill 2024 shall, if not previously concluded, be

interrupted and stand adjourned either at 4.30 p.m. or after 1 hour and 16 minutes, whichever is the later, and shall not be resumed on Wednesday

Wednesday proposal no. 4 - Employment (Collective Redundancies and Miscellaneous Provisions) and Companies (Amendment) Bill 2023
