I wish to acknowledge receipt of your correspondence of 9 June 2021 in the above matter and I am to provide the following by way of response.

There is no additional information which can be provided by An Garda Síochána at this time in connection with the so-called 'Cabra accounts'. As you are aware, the Garda Síochána Ombudsman Commission (GSOC) are conducting an investigation into this matter and An Garda Síochána are cooperating fully with same. In the circumstances, it would not be appropriate for An Garda Síochána to comment on an active investigation as any such comment may be prejudicial to a possible criminal prosecution. It is understood that GSOC have already communicated with the Committee of Public Accounts on this matter.
