1.	All Pro	Cleaning services Government Offices Killarney	42,974	In 2020, the Department was not in a position to retender this contract and continued to engage the services of All Pro Cleaning Services on foot of a previously competitively procured contract.
				The preparation of a new tender was impacted by changes to OGP Framework; Covid-19 and the significant restructuring of the Department. Arrangements for the issue of a tender for cleaning services across all Departmental locations under the new OGP Framework have now been completed. A new contract covering all Department locations will be put in place for 2022.
2.	Eir	Fixed line telephony services	47,326	The initiation of a new contract for fixed line telephony in 2020 was delayed by the impact of COVID-19 and the significant restructuring of the Department during the latter half of the year. The Department has reviewed its fixed line telephony requirements and in the absence of a relevant OGP framework, will shortly initiate a RFT with a view to having a new contract in place for 2022.
3.	Bidvest Noonan	Cleaning services at a number of Departmental sites	50,655	In 2020, the Department was not in a position to retender this contract and continued to engage the services of All Pro Cleaning Services on foot of a previously competitively procured contract. The preparation of a new tender was impacted by changes to OGP Framework; Covid-19 and the significant restructuring of the Department. Arrangements for the issue of a tender for cleaning services across all Departmental locations under the new OGP Framework have now been
				completed. A new contract covering all Department locations will be put in place for 2022.

4.	ECO Group	Cleaning services at the National Archives of Ireland (NAI)	167,314	The NAI continued to engage the services of ECO Group on foot of a previously competitively procured contract. A procurement manager has been appointed at the NAI and a competitive tendering process took place in June of this year. It is anticipated that a contract will be awarded to the preferred tenderer before month end.
5.	Massey & King	Genealogical services at the National Archives of Ireland (NAI)	155,184	The NAI continued to engage the services of Massey& King on foot of a previously competitively procured contract. A procurement manager has been appointed at the NAI and following a competitive tendering process, a new Genealogical Services Contract was put in place in June 2021.
6.	Secureway at Risk Security	Security services at the National Archives of Ireland (NAI)	114,628	The NAI continued to engage the services of Secureway on foot of a previously competitively procured contract. A procurement manager has been appointed at the NAI and the specifications for the new contract have been finalised. The NAI are engaging with the OGP in terms of their framework for security services and a new contract will be in place for 2022.
