## Dear Ms Fallon.

Thank you for your letter of  $15^{th}$  November 2021. We wish to assure the Public Accounts Committee that the University takes matters relating to compliance with procurement guidelines seriously. We have taken significant steps to address non-compliance, going from €4.45M of reported non-compliance in 2017/2018 to €2.9M in 2018/2019 and €1.1m in 2019/2020. We are committed to ensuring procurement compliance in the longer term.

We are herewith providing the information that you have requested.

As you note in your letter, in the period 2019/2020, the University incurred expenditure of €1.1m that was found to be non-compliant with procurement guidelines. This procurement activity was in respect of 32 suppliers where the procedures employed did not comply with procurement regulations. Appendix 1 sets out in tabular form the contracts that were non-compliant with procurement guidelines in 2019/2020, the associated expenditure, goods/services, supplier(s) and the reason(s) for the non-compliance.

The table below summarises the actions that the University is taking to address the reported non-compliance:

The procurement activity with the remaining 15 suppliers falls into two categories:

- Procurement with suppliers that will not recur, therefore putting a contract in place at this juncture would not be appropriate.
- Procurement with suppliers where individual spend is less that the €25K procurement threshold, but the aggregate of spend with the supplier, across a number of contracts, exceeds

the €25K procurement threshold. The University would like to note that in this category the individual procurements were carried out in line with procurement regulations however the aggregate of procurement with the supplier exceeded €25K and, as a result, a different procurement methodology should have been employed.

The University would also like to note additional steps that it has taken to improve its level of compliance with the procurement regulations. These steps have included:

- The Compliance Office is arranging compliance testing in the form of sampling throughout the financial year.
- Procurement policies and procedures are being reviewed and updated to ensure that they are in line with the latest guidelines.
- Investment in IT systems to support the execution of procurement in line with regulations.
- Close engagement with the Office of Government Procurement and the Educational Procurement Service to adopt, and also support the development of, national and sectoral contracts to maximise compliance levels.
