Dear Ms Cremin

I refer to the Committee's correspondence of 24 October 2022 and have set out below and attached the requested information.

1. Further details of the 494 sites in the landfill remediation programme to include their location, what are the outstanding issues, and what actions are being taken to minimise costs being borne by the State

The Regional Waste Management Plans are being updated and consolidated with a view to publishing a single National Waste Management Plan for a Circular Economy in Q1 2023. This will set out the renewed roadmap for delivery of the national policy for the landfill remediation grant programme for the next 7 years.

Attached at Appendix I is a spreadsheet which provides the current position on the status of all 494 sites. This will change over time as the programme continues to be implemented. The term 'commenced', as referenced in Appendix I, has been used to broadly include sites where local authorities have sought funding under the grant programme e.g., some level of works has commenced; 'authorised' means sites now regulated under the Waste Management Act (as amended), 1996; and 'resolved' means sites addressed by local authorities without drawdown of grant funding and no further works are envisioned.



Summary tables of the information in the Appendix I on the 494 sites identified under the landfill remediation programme, is provided below:

This means 390 out of 494 sites have had at least the first level of environmental risk assessment (ERA) completed. Of the 104 sites where an ERA is not available, details are broken down as follows;

- **42** have been authorised and regulated under the Waste Management Act (40 private/illegal and 2 Pre-1977 sites) with no requirement for an ERA. No grant funding was required for the resolution of these sites.
- **33** (private/illegal) have been resolved by local authorities without grant funding and no further work is anticipated.
- **29** remaining sites without an ERA (12 private / illegal and 17 Pre-1977) have commenced works under the grant programme. On completion of the ERA, a risk assessment status will be made available.

This means that out of 104 sites with no ERA status available, 75 have been authorised or resolved and a risk assessment status is not available or required.

All closed Local Authority operated landfills have had at least the first level of ERA completed, meaning they have a risk assessment available. Out of the **271** closed local authority operated landfills:

- **146** are still to commence further ERA and remediation;
- **7** have been remediated; and
- **118** have commenced and are at different stages of ERA for the preparation and implementation of final remediation plans.

Of the **271** closed landfills on the historic landfill register, for which a Certificate of Authorisation (CoA) has to be obtained from the EPA prior to proceeding with any required remediation works:

- **75** CoA applications have been submitted by local authorities to date;
 - **28** have been granted; and
 - **47** CoA applications await a decision.
- **196** CoA applications yet to be submitted.

Since the appointment of the historic landfill coordinators in 2019, the number of CoA applications submitted has increased significantly. It is anticipated that the majority of the CoA applications for the remaining **196** closed landfills will be submitted within the lifetime of the next national waste management plan (due Q1 2023, to run from 2023 to 2029). There is a procurement framework for local authorities in undertaking environmental risk assessments in place since 2021, valued at €7m which could progress over 100 sites through ERA over its lifetime (5 years).

8 sites listed on the closed landfill register have been remediated to date. A breakdown of these is provided in table 3. There are a further 5 due for completion in coming months in addition to 2 other sites that are not on the register and a breakdown of these is provided in Table 4.

*Kerdiffstown was a licensed site which invoked waste enforcement intervention due to operating outside of its licensing conditions.



Actions to reduce cost borne by the State

Significant steps have been taken to strengthen the governance of the landfill remediation grant programme in recent years. The establishment of the national steering group in 2019 allows for quarterly monitoring of the annual funding allocations, with progress reports allowing for the reallocation or increase of funding across the year. Where a project may run into delays or underspend, this is identified at the earliest opportunity to re-allocate funds within the annual budget, ensuring optimum allocation of grant support, responding directly to project progress across the programme as a whole. The funding allocations and project progress are managed in accordance with the Public Spending Code and Circular 13/14.

A procurement framework has been established for local authorities to engage consultants to complete environmental risk assessments in preparation of a site resolution plan for final remediation works. This will increase efficiency in procurement and should improve timelines for delivery.

Grant funding was increased to 100% in 2018 to encourage drawdown of funding by local authorities. This was supported through the roll-out of EPA Code of Practice training on ERA which has built knowledge at local authority level and supported the growing momentum in the programme. The number of projects supported has grown year on year to over 130 in 2022.

Further steps that have been taken are summarised as follows:

- Dedicated EPA inspector processing Certificates of Authorisation since 2018.
- Two regional co-ordinators in place across the regional waste planning offices since 2019.
- A procurement framework for local authorities in undertaking environmental risk assessments is in place since 2021, valued at €7m, in place for the new national waste management plan to be published in 2023. Training is being provided to local authority staff.
- High risk and private/illegal sites have been prioritised for commencement and funding over the lifetime of the regional waste management plans 2015 – 2021.
- Closed landfill register (formerly Section 22 register) now revised with ICT support in place to utilise the database to track progress.



2. Details of the landfill remediation programme in Coolock/Darndale.

Background to site

In its capacity as chair of the National Waste Enforcement Steering Committee (NWESC), the Department first wrote to Dublin City Council (DCC) in March 2019 regarding an alleged large scale illegal dumping site on a green space between the R139 road and a residential area in Moatview, Darndale.

The Environmental Protection Agency (EPA), who also sit on the NWESC, recommended that the Committee consider what further action could be taken in relation to this matter in line with the National Waste Enforcement Priorities for 2019, which included “illegal waste activity, the enforcement of which requires a multi-agency response and dealing with sites of concern”.

A number of regulators and Government Departments sit on the NWESC including the EPA, the County & City Managers Association (CCMA), the Waste Enforcement Regional Lead Authorities (WERLAs), the National Transfrontier Shipments Office (NTFSO), the National Waste Collection Permit Office (NWCPO), An Garda Síochána, the Office of the Revenue Commissioners and the Department of Social Protection. The EPA’s correspondence was circulated to the membership of the Committee to consider its contents with a view to examining a multi-agency response to this situation. Officials from the Department, the EPA and DCC also attended an on-site inspection at that time, with support from An Garda Síochána, from which it was evident that there was a large degree of criminality occurring at the site, not all of which was waste related.

Current Position

The multi-faceted nature of the issues involved at this site require a holistic response from regulators. The NWESC has provided assistance in bringing together different relevant member agencies to support DCC in their efforts such as An Garda Síochána, Revenue and the Department of Social Protection. DCC themselves have established a cross departmental task force, encompassing various council departments including Housing & Community, Environment & Transportation, Planning & Property Development and Culture, Recreation and Economic Services. This local authority task force has been active in examining ways to prevent further illegal dumping at this site and are working in conjunction with both the residents and local Gardaí.



The latest update provided by DCC to the Department in July of this year advised that enforcement actions at the site have included the prosecution of individuals under the Waste Management Act and the revocation of the waste collection permit of a local resident. There have been continuous enforcement actions taken since 2019, including surveillance, road checkpoints, the service of notices under the Waste Management Act and the impounding of vehicles owned by local residents engaged in the alleged unauthorised collection of waste. Further prosecutions have been initiated, while there are a number of investigations ongoing, with the assistance of An Garda Síochána, into continuing breaches of the Waste Management Act. Patrols, together with regular clean-up and maintenance operations by DCC are continuing.

DCC further advised that the ultimate objective is to clean up and secure the site as part of an overall sustainable solution, which will include development of the site and surrounds by DCC. Specialist Environmental Consultants have been engaged by DCC to undertake Environmental Assessments to gauge both the scale and type of waste involved and to advise on the subsequent means and level of clean up required. The clean-up of this site will be carried out in conjunction with plans for the overall development of the area by DCC. Department officials will receive further reports from DCC and via the NWESC as this progresses. In the interim, DCC are actively engaged at a senior level with An Garda Síochána in efforts to eliminate illegal dumping in this area.

Tackling illegal dumping and other waste crime is a priority for the Department, which continues to provide significant operational and financial support to local authorities dealing with challenging waste enforcement cases through both the Anti-Dumping Initiative and the Sites of Concern Programme.



3. Further details regarding the purchase of additional temporary generation capacity to include whether additional capacity has been secured, is it on stand-by, the overall cost, and what type of fuel is being used in the generators.

Purchasing of additional temporary generation capacity

As part of the Commission for Regulation of Utilities (CRU) programme of actions to ensure security of electricity supply, measures have been put in place to secure temporary generation capacity. The first tranche of temporary generation (c.250MW) was due to be delivered by Winter 2022/23. Due to delays to the procurement process this will now not be delivered for this winter and will instead be delivered in 2023. The delays to the procurement of this first tranche of temporary generation have informed the process to be used for the second tranche.

In June 2022 CRU directed EirGrid to procure - using the most expeditious means available - circa. 450MW of additional temporary generation capacity from the winter of 2023/24 to winter 2025/26 to ensure a secure electricity supply. Emergency legislation was enacted in July to support this action by EirGrid.

Commercial negotiations are being finalised currently by EirGrid with the equipment manufacturers and relevant site owners, with units to be ordered shortly for delivery in Autumn 2023.

The units will only be used occasionally in situations where there is low renewable generation and interconnection capacity available to meet peak demand. All other capacity market generation must be exhausted before these units are called into service as they are a backup form of capacity.

Cost:

In June 2022, Government agreed to support the delivery of a second tranche of temporary emergency generation capacity (c.450MW) as directed for by the CRU. EirGrid estimated that the level of financial support required from the Department to support EirGrid to meet the upfront capital cost is €350 million in 2022. Government agreed to provide that support in two supplementary estimates to Vote 29.



The €350m capital will be used by EirGrid to place orders on the units to ensure that they are produced and installed for Winter 2023/24. The ongoing operational costs will be administered from the Transmission Use of System (TUoS) network tariffs and spread out over the lifetime of the usage of the generation plant.

However, this cost estimate does not take into account the resale value of the generation units at the end of the generation period in a few years' time. This resale value could offer significant clawback of costs which would lower the cost to consumers in subsequent years.

Fuel type to be used in temporary generation units

The generation units are open cycle gas turbines that can be ramped up and down quickly to respond to demand peaks unlike traditional base load generation plant. Most generation units of this kind can be run on both gas and distillate as required. However, the units for the second tranche will be based on sites that don't have gas connections and thus will be distillate fired generation. The units will only be used occasionally in situations where there is low renewable generation and interconnection capacity available to meet peak demand and are purely back-up capacity.
