Information on non-compliant procurement in 2021

Dear Ms Cremin,

I refer to your letter of 30th December 2022 requesting an information note on non-compliant procurement in 2021.

In 2021 this Department incurred €133.6m on procurement of goods and services. At all times the Department ensures that there is an appropriate focus on good practice in procurement and that procedures are in place to ensure compliance with relevant guidelines and legislation.

EU and national rules promote an open, competitive and non-discriminatory public procurement regime which delivers value for money. EU Directives declare that there can be legitimate reasons for awarding contracts non-competitively, such as extreme urgency brought about by unforeseeable events or if there is a single supplier to perform the contract. Therefore, a non-competitive procurement is not necessarily non-compliant with procurement rules.

In relation to non-compliant procurement, in 2021 the Department complied with the guidelines except for 64 contracts totalling €3,787,740.43 (ex. VAT). Details of those contracts are set out below in tabular form as requested.
