Part 1 Vote 30: DAFM 2021

The gross voted allocation of the Department of Agriculture, Food and the Marine in 2021 amounted to $\leq 1,826.118$ m, comprising $\leq 1,526.825$ m in current and ≤ 299.293 m in capital. In addition, a carryover of ≤ 31.6 m capital from the 2020 allocation was permitted meaning the total funds available to the Department in 2021 was $\leq 1,857.719$ m. When the capital carry-over and appropriations in aid of ≤ 363.789 m are taken into account, the 2021 net vote estimate was $\leq 1,493.930$ m.

Gross Expenditure was €1,692.718m with appropriations in aid of €386.665m resulting in net expenditure of €1,306.053m. The table below summarises the information for 2021.

In addition to the Voted Exchequer funds, the Department is responsible for distributing €1.2bn in "non Voted" funds. These are 100% EU funded monies which relate to the Basic Payment Schemes.

Structure of Vote

The Vote is sub divided into 4 expenditure programmes corresponding to the 4 key Strategic Objectives set out in the current Statement of Strategy (programmes A to D). The programme allocation figures shown in table 2 include the proportion of the Department's administrative budget to be spent in the delivery of each of the Programmes. When shown separately, the 2021 DAFM Administrative Budget allocation was €327.139m of which €214.031m was pay and €113.108 was non-pay. (details on page 13).

Vote performance in 2021

Gross expenditure in 2021 was €1,692.718m, which was 91.1% of the available €1,857.719m.

Much of the Department's Vote comprises schemes and measures that are subject to external factors such as demand from beneficiaries, market and economic and environmental factors, animal disease incidence, and the pace of completion of capital investment and research projects. Despite the continuing challenges of the Covid-19 pandemic and Brexit we continued to carry out our usual business in 2021.

To allow a technical supplementary estimate to take place a token €1,000 was added to the Department's vote. No additional funding was requested. This technical supplementary estimate allowed the Department to make use of €49.8m savings on the Department's vote to provide for spend over several headings.

The Technical Supplementary Estimate allowed savings to be moved to fund -

- An increase in the Sheep Welfare Scheme allocation,
- The Future Growth Loan Scheme (FGLS) which the Department co-funds with the Department of Enterprise, Trade & Employment. It supports strategic long-term capital investment by SMEs, farmers and fishers
- An early payment to the World Food Programme.
- The Marine Institute
- A Brexit Temporary Fleet Tie-up Scheme managed by Bord Iascaigh Mhara.

Carry-over

Public financial procedures allow for the carry-over (known as "deferred surrender") of unspent capital funds in some circumstances subject to approval. Accordingly, DAFM carried forward €31.6m of capital from its 2020 allocation into 2021. (Under the same procedures €19.8m had been carried into 2020 from 2019).

Appropriations-in-aid

The Department's budgeted total appropriations-in-aid for 2021 was €363.789m, over 80% of which was to EU co-funding. However actual appropriations in aid were €386.665m, the difference due to a funding rate of 85% in 2021, which was reimbursed from the EU in December 2021.

The bulk of the EU transfers arise under the RDP 2014-2020 with the remainder relating to fisheries (EMFF) animal health measures (veterinary fund co-funding for BSE, TB etc), and some relatively minor co funding amounts relating to market support technical costs etc.

The balance of receipts relates to charges for inspection and certification services e.g. inspection of meat and dairy premises, certification of live animal exports, laboratory services as well as pension levy deductions and other salary refund receipts.
