Hi Pat,

As per the attached invitation the Secretary General has been invited to attend the PAC on May 11 to discuss a number of topics including the administration of the Health Repayment Scheme (nursing home charges).

At a meeting of Government on 7 February 2023, the Minister for Health was requested to revert to Government within three months having considered the Attorney General's report on Nursing Home Charges including the administration of the Health Repayment Scheme. The Department is currently finalising this briefing, and intend to present a copy to the Minister in the week of May 8th. The Minister will then consider the briefing and if approved, will then revert to Government during the week of May 22nd.

On the basis of the timeline set out above, it will not be possible for the Secretary General to speak to this matter with the Committee ahead of the matter being considered by the Minister and Government. On this basis, we propose that this topic is deferred by the Committee for a number of weeks.

I would be grateful if you could confirm that the Committee would be happy for this item to be removed from the agenda.
