Dear Ms. O'Farrell,

I refer to your letter of 9 May 2023 outlining queries on a number of issues raised by Committee members at the meeting of An Bord Pleanála with the Committee of Public Accounts on Thursday 27 April 2023.

An Bord Pleanála responds as follows:

1. The number of cases that have gone from the High Court to the Court of Appeal and to the Supreme Court (pg. 13).

Please see attachment titled 'Q1. Number of Cases from HC to COA to SC'

- 2. In the case of withdrawn cases, the average timeline between initiation of and withdrawal (pg. 13). Please see attachment titled 'Q2. Timeline for Withdrawn Cases'
- 3. A note on minimum density, including information on the legal basis for a minimum density requirement in planning policy of 35 dwellings per hectare (pgs. 21-22).

The legal basis for a minimum density requirement is a policy issue which is outside of the remit of An Bord Pleanála and was covered by Mr. Paul Hogan, Acting Assistant Secretary General of the Department of Housing, Local Government and Heritage at the meeting on 27 April 2023.

- 4. The number of judicial reviews per year, broken down between first-party and third-party reviews, prior to and after the introduction of the Strategic Housing Development (SHD) process (pg. 27). Please see attachment titled 'Q4. Breakdown of New JRs between 1st and 3rd party 2017- 2022'
- 5. A breakdown of the cases that have been in progress for three years or more by type (pg. 36). Please see attachment titled 'Q5. Cases on Hand greater than 3 years on 17 May 2023'. It should be noted that of the 50 cases recorded within the system, 26 are pre-application consultation cases in relation to strategic infrastructure proposals, which have not been closed by the applicant or an application for consent made, but cannot under the current legislation be closed by An Bord Pleanála for failure to pursue the application.
- The percentage of the €10 million spent on legal fees in 2022 that was spent on judicial review
 cases and a breakdown of that expenditure by cases won, lost and conceded by An Bord Pleanála
 (pgs. 38-39).

The percentage of the overall legal costs spent on judicial review cases was 96.5% (a total of 9.637M).

€5.053M of the €9.963M was in relation to liabilities for "other side" costs primarily relating to cases lost or conceded by the Board. The breakdown of those "other side" cost liabilities was as follows: conceded cases 60.14%, lost cases 38.45% and cases won 1.41%.

These are draft figures awaiting finalisation and C&AG approval.



I Assistant Director of Planning

3 additional Inspectors to bring the total number of inspectors working on SHD to 16

2 Executive Officers and 2 Administrative Assistants in supporting admin roles





On 3 December 2021, the previous Chairperson issued a request to the Minister for Housing, Local Government and Heritage on resourcing requirements which included a further request for the following staff for the SHD Unit:

- 6 Senior Planning Inspectors
- 1 Planning Inspector
- A note on staffing numbers prior to and after the introduction of the SHD process and whether staffing levels were evaluated as sufficient prior to and after the introduction of the SHD process (pg. 43).
