Timeline of Requests and Sanctions

The Department of Finance wrote to DPENDR with a business case regarding a proposed TAC pay scale restructuring on the 23rd June 2021. The request is summarised below. The key take away was a restructuring of staff under a new tiered system. Sanction for the restructuring of the Tax Appeals Commission was granted by DPENDR on 12th July 2021.

On the 16th of December 2022 a request for an additional two Tier 3 Commissioners was received by DPENDR from the Department of Finance. Sanction for this request was granted by DPENDR on 17th January 2022.

A further restructuring request was received on the 9th of March 2023, with the Department of Finance requesting that Tier 1 posts be changed to Tier 2 posts, once current contracts had expired for the Tier 1 Commissioners. Sanction for this request was granted by DPENDR on 14th July 2023.

Finally, on 12th July 2023 the Department of Finance submitted a business case to DPENDR requesting a pay scale change for Tier 2 Appeal Commissioners from €165,472 to €154,160. Sanction was granted by DPENDR on 14th July 2023.
