

## CCMA Opening Statement to the Joint Committee on Children, Equality, Disability, Integration and Youth

The adequate and timely accommodation of refugees, asylum seekers and international protection applicants.

30<sup>th</sup> May 2023

Chairman, Members,

I am pleased to be here this afternoon to assist the Committee in its examination of issues facing us in relation to the adequate and timely accommodation of refugees, asylum seekers and international protection applicants.

My name is Michael Walsh, Chief Executive, Waterford City and County Council, chair of the Accommodation Technical Working Group and member of the City and County Management Association (CCMA) Housing, Building and Land Use committee. I am accompanied here today by Sinead Carr, Director of Service, Tipperary County Council and Niamh McCarthy, National Coordinator, Emergency (Ukraine) Unit, LGMA.

Local authorities, as the key operational arm of government, have fully supported and assisted the whole of government approach to the Ukrainian humanitarian crisis. We stepped up when the need was most acute, establishing 27 emergency rest centres in the early months of the response, supporting the Irish Red Cross pledge programme and sourcing local available commercial accommodation as part of the critical response when numbers of Ukrainian Beneficiaries of Temporary Protection (BOTPs) continued to rise.

Building on experience, structures and relationships developed during the community call response to Covid 19, each local authority has repurposed their Community Response Forum for the Ukrainian Response to provide coordination through local community action groups, working with various services and agencies.

This typically involves activities such as:

- The provision of information and supports to accommodation centres prior to arrivals, and throughout activation.
- Holding welcome events
- Working with the education sector, particularly around local school enrolment



- Identifying local flexible transport options
- Providing information on services to community groups and other contacts such as PPN members, Gardaí and other agencies.
- Providing practical supports such as with medical card applications, CV, interview skills, employment, social and integration supports.

Since November 2022, the local government sector has led out on 'Offer a Home', a national call for unoccupied homes, including mounting national and local awareness campaigns. Each local authority established relationship managers, took full responsibility for all contact with property owners, inspection of properties and allocating of beneficiaries to the suitable properties. To maximise the utilisation of homes offered under the scheme, a Community Car Scheme initiative was also included. This scheme is available to service rural housing and housing offers where there is no public transport to maximise the number of offers that can be accepted.

The LGMA put in place a national system for the registration of properties and to manage the full end-to-end process. To date more than 2,300 properties have been offered.

- 94% of those who made offers have been successfully contacted
- 94% of properties have been assessed of which:
  - o 54% were suitable for occupation
  - o 32% were withdrawn or not viable
  - 11% require some minor works
  - 2% have assessment underway
- Of the 1,228 properties deemed suitable, a total of 980 (80%) have been allocated
- Overall, 3,100 beneficiaries have been allocated to homes to date

An Accommodation Working Group was established to support the Department of Integration and the Department of Housing in their respective roles in supporting the delivery of accommodation.

I chair the Technical Working Group that reports into the Accommodation Working Group around the refurbishment programme of work. The Technical Working Group has representation from DCEDIY, DHLGH, Department of the Taoiseach, the OPW and the CCMA. Building on the work undertaken in 2022 the group has:

- Put in place a clear matrix of assessment, against which all projects are assessed.
- Set up a method of tracking all projects across four categories of refurbishment.
- Put in place a streamlined process on progression of projects across legal, regulatory and commercial frameworks.
- Developing guidance on standards, following on from the publication of the guidance in May 2022.



The table below provides a high-level overview of the scale of the programme of work:

The following projects have received capital funding from the Department of Housing Local Government and Heritage and are now in use by the Department of Integration, providing 328 beds.

Over recent months there has been extensive engagement with the Chief State Solicitor's Office (CSSO) to define a clear legal framework in terms of contract duration and template documents. These have been agreed and are being developed.

The focus while the legal and planning framework is being finalised has been on local authority and state-owned land with the following at various stages of the process.
