Content and Format of Report

This report has been prepared pursuant to Standing Order 100 (3), (4), (5) and (6), (Dáil Éireann) and Standing Order 77 (3), (4), (5) and (6) (Seanad Éireann) which provide for the Joint Committee to-

- undertake a review of its procedure and its role generally
- prepare an annual work programme
- lay minutes of its proceedings before both Houses
- make an annual report to both Houses.

At its meeting on 15 September 2022, the Joint Committee agreed that all these items should be included in this report covering the period from 30 September 2020 to 31 December 2021.

2. Establishment and Functions

2.1 Establishment of the Joint Committee

The Joint Committee on Disability Matters was established following Orders of Dáil Éireann and of Seanad Éireann on 22 September 2020 and 25 September 2020 respectively.

2.2 Functions of the Joint Committee

Among the principal functions of the Joint Committee are to consider and report on the 'Implementation Plan' for the United Nations Convention on the Rights of Persons with Disabilities (UNCRPD) and national strategies including the National Disability Inclusion Strategy and sector strategies

and the effectiveness of

(i) all national processes established to implement the UNCRPD

(ii) the National Framework for Monitoring the implementation of the Convention including engagement with the Irish Human Rights and Equality Commission and the National Disability Authority.

The Orders of Reference of the Joint Committee are set out at Appendix 1.

3. Cathaoirleach, Leas Cathaoirleach and Membership

Dáil Standing Order 104 (2) provides for a proportion of Chairs to be allocated to each group by means of the D'Hondt System. Deputy Michael Moynihan was appointed as Cathaoirleach of the Joint Committee on 30 September 2020 by an Order of Dáil Éireann.

Deputy Pauline Tully was appointed Leas- Cathaoirleach on 9 December 2020.

4. Meetings, Attendance and Recording

Meetings of the Joint Committee took place in the Committee Rooms in Leinster House 2000. Due to Covid restrictions the business of the Committee was limited to essential business only during level 5 and private meetings were held over Microsoft Teams. The Covid restrictions impacted the number of meetings held and the witness participation over the period 2020 and 2021.

Committee proceedings were broadcast live within Leinster House, and made available to RTE, TV3 and TG4. Proceedings were also live streamed on our website and through our app. Since September 2014 the proceedings of Committees in public session, typically recorded but occasionally live, are broadcast on the dedicated parliamentary channel Oireachtas TV which is available on these channels:

5. Number and Duration of Meetings

5.1 Joint Committee

The Committee met privately 53 times in 2020/2021. These meetings were held online in order to reduce the number of onsite meetings during the Covid Pandemic. In relation to public meetings, members and witnesses were also facilitated to attend these online and/or other measures were taken in order to minimise health risks during the pandemic.

The Joint Committee publicly met on 69 occasions during the period under report. The number of hours of discussion involved in these meetings was in excess of 85.23 hours.

The subject matter of each meeting of the Joint Committee, including the groups, organisations or individuals who attended the meetings, is detailed in *Appendix 3*.

Appendix 1 – Terms of Reference of the Joint Committee

Orders of Reference - Dáil Éireann

(1) That a Select Committee consisting of 9 Members be appointed by Dáil Éireann to form the Joint Committee on Disability Matters to consider all disability matters including monitoring the implementation (by Ireland) of the United Nations Convention on the Rights of People with Disabilities.

(2) That the Select Committee on Disability Matters shall consider and report on(a) the 'Implementation Plan' for the United Nations Convention on the Rights of
Persons with Disabilities (UNCRPD) and national strategies including the National
Disability Inclusion Strategy and sector strategies for the purpose of-

 (i) ensuring implementation plans are configured to advance the UNCRPD while delivering outcomes for persons with disabilities in their lived experience and planning into the future;

(ii) making recommendations which align the plans and strategies of Ireland's international obligations;

(iii) monitoring progress of the drafting and initiation of required and relevant legislation;

(iv) engaging with Ministers and the Secretaries General of relevant Government departments regarding implementation measures and budgetary measures;

(v) aligning the UN Sustainable Development Goals with the provisions of the UNCRPD;

(vi) supporting the embedding of a rights-based approach to disability as provided by the UNCRPD within Ireland's economy, society, and culture;

(vii) reviewing Ireland's Report/s to the UNCRPD Committee;

(viii) monitoring and ensuring the timely implementation of the Optional Protocol of the UNCRPD;

(b) the effectiveness of-

(i) all national processes established to implement the UNCRPD.(ii) the National Framework for Monitoring the implementation of the Convention including engagement with the Irish Human Rights and Equality Commission and the National Disability Authority.

(3) For the purposes of paragraph (2) the Committee shall-

(a) engage with persons with disabilities, family carers, Disabled PersonsOrganisations, service providers and advocates in the Committee's work;(b) consider other topics that the disability community identifies as key as agreed by the Committee;

(c) have regard to Concluding Observations of the UN Committee on the Rights of Persons with Disabilities (UN Committee) with respect to Ireland's periodic reports, review the Government response to the Observations of the UN Committee and make its own recommendations with respect to same.

(4) The Joint Committee shall have the powers defined in Standing Order 96, other than paragraphs (3) to (9) inclusive thereof;

(5) The Chairman of the Dáil Select Committee shall also be Chairman of the Joint Committee

Orders of Reference - Seanad Éireann

(1) That a Select Committee consisting of 5 Members to be appointed by Seanad Éireann to form the Joint Committee on Disability Matters to consider all disability matters including monitoring the implementation (by Ireland) of the United Nations Convention on the Rights of People with Disabilities.

(2) That the Select Committee on Disability Matters shall consider and report on-(a) the 'Implementation Plan' for the United Nations Convention on the Rights of Persons with Disabilities (UNCRPD) and national strategies including the National Disability Inclusion Strategy and sector strategies for the purpose of-

(i) ensuring implementation plans are configured to advance the UNCRPD while delivering outcomes for persons with disabilities in their lived experience and planning into the future;

(ii) making recommendations which align the plans and strategies of Ireland's international obligations;

(iii) monitoring progress of the drafting and initiation of required and relevant legislation;

(iv) engaging with Ministers and the Secretaries General of relevant Government departments regarding implementation measures and budgetary measures;

(v) aligning the UN Sustainable Development Goals with the provisions of the UNCRPD;

(vi) supporting the embedding of a rights-based approach to disability as provided by the UNCRPD within Ireland's economy, society, and culture;

(vii) reviewing Ireland's Report/s to the UNCRPD Committee;

(viii) monitoring and ensuring the timely implementation of the Optional Protocol of the UNCRPD;

(b) the effectiveness of-

(i) all national processes established to implement the UNCRPD;

(ii) the National Framework for Monitoring the implementation of the Convention including engagement with the Irish Human Rights and Equality Commission and the National Disability Authority.

(3) For the purposes of paragraph (2) the Committee shall-

(a) engage with persons with disabilities, family carers, Disabled Persons Organisations, service providers and advocates in the Committee's work;

(b) consider other topics that the disability community identifies as key as agreed by the Committee;

(c) have regard to Concluding Observations of the UN Committee on the Rights of Persons with Disabilities (UN Committee) with respect to Ireland's periodic reports, review the Government response to the Observations of the UN Committee and make its own recommendations with respect to same.

(4) The Joint Committee shall have the powers defined in Standing Order 72, other than paragraphs (3) to (9) inclusive thereof;

(5) The Chairman of the Dáil Select Committee shall also be Chairman of the Joint Committee
