Query: Full detail of all projects (including, but not limited to, those in relation to productions, equipment, capital works, or personnel) that were cancelled over the period 2019-2023

Response:

Below is a list of cancelled projects in Operations, Technology and Property and Services:

Air Handling Unit Compliance	Operations	50,000	2 0 2 0	Cancelled due to Covid protocols at the time. Contractors were not available and it would not have been possible to have the required number of people on site in confined areas. Work still outstanding and new project will be raised.
Floor Covering & Blinds	Property & Services	€50,000	2 0 2 2	Project as originally scoped was cancelled. This was a general project to address floor coverings and blinds across the site. Given the state of three toilet blocks in TV Building made sense to redirect funds to the refurbishment of those, which included replacement of floors in those toilet blocks.
Protective Coatings External Building Fabric	Property & Services	€50,000	2 0 2 2	Project as originally scoped was cancelled. This was a general project for interior painting and external painting. Funds redistributed to the refurbishment of three toilet blocks in the TV Building.
Music Returns	Technology	€50,000	2 0 2 2	Once project was approved, the team identified an alternative strategy - and developed a SharePoint site to meet the needs.

Production:

During the period 2019 to 2023 no programming was cut for cost reasons. Editorial choices drive changes in the television, radio, and digital channels. The statutory amount RTÉ was required to spend in 2020 was €40.2m (2019: €39.9m). In 2020 RTÉ paid into the Independent Programmes account the full amount in accordance with the Broadcasting Act 2009.

However, due to the Covid-19 pandemic and the cancellation or postponement of many productions, RTÉ was not in a position to expend the full amount. While many productions were able to adapt their production methods, some types of programming were prevented by public health advice and pandemic restrictions. In 2020, total statutory expenditure was €36.5m, which was €3.7m below the statutory requirement.

As per the Broadcasting Act 2009, any monies not expended in 2020 will be spent within the following two years.

2021 was Ireland's second year of Covid, and a full year of pandemic restrictions of varying levels. Indeed, the year began under full Level 5 restrictions. 2021 was a year of sustained production and investment in the Irish independent audiovisual sector, which saw RTÉ not only achieving its annual statutory spend but also making up the shortfall in spend from 2020.
