*Minutes of the Commission Thursday,*  $25^{th}$  *October,* 2007

1. The ninth meeting of the Commission of 2007 took place at 2.30 p.m. in Room 2, Leinster House.

#### 2. Members present.

#### **3.** Estimates 2008.

#### Statement of Estimates 2008.

The Commission approved the statement of estimates for the period 1 January 2008 to 31 December 2008, as set out in the *Appendix* to these minutes, for publication and presentation to Dáil Éireann by way of take note motion in accordance with section 13 of the Houses of the Oireachtas Commission Acts 2003 and 2006.

#### Sanction for Virement.

The Commission granted sanction to vire monies between subheads 1(b), 1(c), 1(e), 1(g), 2(a), 2(b), 2(c), 2(f), 2(j), 3(a), 3(b), 3(c), 4(a), 4(b), 5(b) and 5(c) to meet excesses projected on subheads 1(a), 1(d), 1(f), 2(i), 5(a), 6(a) and 6(b): provided that no virement should occur in the case of subheads 2(d), 2(e) and 2(h).

The Commission delegated authority to the Secretary General to vire additional funds between subheads in respect of expenditure incurred before 31<sup>st</sup> December, 2007, and agreed to formally note the final position in relation to virement as soon as may be following the closure of the 2007 Account.

The Commission was advised that an excess is anticipated on subhead 2(h), the grant-in-aid funding An Ciste Pinsean, and that the limit of provision should be reached by end of November.

#### 4. Adjournment.

The meeting adjourned at 3.05 p.m.
