Houses of the Oireachtas Service Working Group on Parliamentary Privilege and Citizens' Rights Terms of reference [As agreed by Dáil Committee on Procedure and Seanad Committee on Procedure and Privileges]

Purpose of the Working Group: To report with recommendations to the Dáil Committee on Procedure and the Seanad Committee on Procedure and Privileges on –

- the changes to the Standing Orders of both Houses of the Oireachtas, and
- any other related actions,

which are considered necessary, by way of response to the recent Supreme Court judgments in the *Kerins* and *O'Brien* cases, and in order to fulfil the Constitutional obligations of the Houses of the Oireachtas to provide protection for the rights of citizens in respect of matters which occur within the Houses of the Oireachtas and their Committees.

Specific areas to be considered: Without prejudice to the generality of its overall purpose, the Working Group shall consider and report on the following matters:
