2021 REVISED Approved level of Net Expenditure

Dear Ciarán,

In line with the Health Act 2004, as amended, I am writing to set out the revised 2021 net expenditure determination for the Health Service Executive (the Executive).

In my letter of 3rd November 2020, I advised that in accordance with Section 30A (1) of the Health Act 2004, as amended, the maximum amount of net non-capital expenditure and net capital expenditure that may be incurred by the Executive for the financial year 2021 is €20,371.5 million and €1,020.3 million respectively. In addition, a sum of €261.6 million (inclusive of €2.450 million Dormant Accounts and COVID-19 funding) is being held by the Department for the specific new initiatives.

I now wish to advise of additional adjustments which will result in a revised maximum level of net non-capital and net capital expenditure that may be incurred by the HSE for the financial year 2021 of €20,362.0 million and €1,033.3 million respectively. In addition, a sum of €261.1 million (inclusive of €2.450 million Dormant Accounts and COVID-19 funding) is being held by the Department for the specific new initiatives. The revisions are summarised in Table 1 below. Further detail is provided in the Appendices attached.

Other COVID-19 measures - reduction of €10 million

In order to meet the estimated costs associated with the e-Passenger Locator Form (e-PLF), €10 million in funding has been reallocated from the HSE's allocation for Other COVID-19 measures (€248.8 million), currently held centrally in the HSE, into the Department's subheads. The HSE allocation is reduced to €238.8 million, with a total COVID-19 Programme Allocation of €1,676 million. Please Appendix A for detail.

COVID-19 Programme- internal reallocation from PPE to COVID19 Vaccination Programme

As you are aware, the Government approved the National COVID-19 Vaccination Strategy on 15th Dec 2020. To support and streamline the implementation of the strategy, I am reallocating an initial fund of €200 million to the HSE from within total 2021 resources and this letter conveys the necessary expenditure approval for the HSE to proceed, up to that amount, subject to the conditions below.

I am directing that within the overall adjusted allocation of €1,676m for COVID-19 Programme in 2021, the following further funding adjustments are made:

- Funding of up to €112 million is allocated, with related expenditure approval, on a gross
 expenditure basis for the purchase of approved COVID-19 vaccines.
- A further initial allocation of up to €88 million is allocated to the overall programme costs of delivering the COVID-19 vaccination programme in 2021, bringing the overall initial funding allocation for the COVID-19 vaccination programme, and related expenditure approval, to a total of €200 million for 2021.

 In turn, the allocation, and related expenditure approval, for the purchase of Personal Protective Equipment for 2021 within the COVID-19 programme is to be reduced from €650 million to €450 million to reflect the updated information relating to closing 2020 stock levels.

All funding for COVID-19 allocations remains ringfenced strictly to that purpose and is subject to ongoing review by the Department in 2021, as provided for in Section 30A (3) of the Health Act 2004, as amended. COVID-19 funding is also subject to the following additional conditions:

- The HSE is required to submit the final fully costed estimate for the COVID-19 vaccination programme in early 2021 for my approval. This will in turn be considered by Government.
- In line with the COVID-19 sanctioning processes, exceptional items that traditionally require separate Ministerial / Departmental approval including contractual arrangements with individual provider groups such as GPs and Pharmacists must be sanctioned by the Department in advance.
- Expenditure on the COVID-19 vaccination programme should be reflected in the Flash report, and further ongoing periodic reporting requirements in relation to the progress of the COVID-19 vaccination programme will be agreed between the Department and the HSE.

It is a matter for the HSE to ensure that all funding is expended in line with Public Financial Procedures and represents value for money.

Holdback Funding – reduction of €0.5 million

Holdback funding has been reduced by €0.5 million, increasing the Existing Level of Service allocation by €0.5 million. Please see *Appendix B* and *Appendix C* for detail.

Winter 2021/22 Influenza Vaccines- €65.5million

Approval is hereby granted to the HSE to proceed with implementation of the delivery of the expanded influenza vaccination programme for the Winter 2021/22 Influenza season at a cost of up to €65.5 million. This initiative, which is in addition to what had been set out in Budget 2021 and proposed for NSP2021, is to be funded in the first instance from the savings that may arise from within the existing allocation of €2,071 million¹ for COVID-19. My Department will work closely with the HSE throughout 2021 to facilitate the reallocation of any savings that may emerge across ring-fenced COVID-19 programmes and also to access the centrally held COVID-19 contingency funding as necessary.

¹ The COVID-19 allocation for 2021 is inclusive of €1,676 million for current expenditure, €155 million for COVID-19 capital expenditure and a further contingency of €240 million provided for and held by central Government in 2021.

Expenditure on the Winter 2021/22 vaccination programme should be reflected in the Flash report.

Brexit Capital – increase of €13 million

An additional €13 million in capital funding has been allocated to the HSE for the ongoing Brexit infrastructure development work at Dublin and Rosslare Ports being conducted by the OPW on behalf of the HSE and other bodies. This infrastructure will allow the HSE to undertake full third country checks on goods arriving from the UK following the end of the transition period. Please see *Appendix*

D for detail.

Technical adjustments - NHSS, PCRS

Within this overall revised sum, certain expenditure items have specific sanctioned levels as set out

hereunder:

• NHSS has been adjusted to a minimum level of expenditure of €1,044.2 million. This net

adjustment incorporates the retention by the HSE of €30m to enhance the sustainability of

the delivery of public residential care for older people. This funding is ringfenced for this

specific purpose and subject to the agreement of the Department on the sustainability

programme. Engagement is ongoing between the Department and the HSE in relation to the

reform deliverables for 2021.

PCRS has been adjusted to a minimum level of core programme expenditure of €3,194.1

million (excl. €50 million new drugs funding)

relation to the specific details of this revised allocation.
