Definitions:

This is hosted by the State Claims Agency (SCA) for the HSE, other Healthcare enterprises and State Authorities. An incident can be a harmful Incident (Adverse Event), no harm incident, near miss, dangerous occurrence (reportable circumstance) or complaint.

Damages: The compensation paid to a claimant in personal injury claims for the pain and suffering arising from a physical and/or mental injury (known as General Damages). The compensation paid to a claimant for out of pocket expenses incurred such as loss of earnings, vehicle damage, etc. (known as Special Damages).

Transaction Reporting Date: This refers to the date that payments were issued.
