

Steps undertaken by the NTPF before upload to database

Before uploading the concatenated file there are a number of changes and formatting required to the file. There were also a number of work arounds created and assumptions made around the data to facilitate the pilot project, in particular the identification of potential planned procedures through the use of order priority fields and the calculation of an indicative date. There is no restarting of waiting time clocks in the development of these reports.

- Anonymise file – the removal of all Patient Individual Identifiers (PII's) from the CSV file once received before being concatenated.

- Order Priority – As agreed for the pilot, all blanks within the Order Priority field were converted to Routine

- File Date – A column was added to include the file extraction date based on the file header and name configuration

- Days Since Ordered – A column was added to calculate the Days Since Ordered (NUMDAYS) the formula was File Date – Order Date

- Hospital Group – Column identifying the hospital group was also added before uploading

There are a large number of exclusions from the extract files in the form of the Radiology Waiting List Data Profile as developed by the Planning and Performance, Acute Hospitals Division, HSE , the National NIMIS team and the NTPF.

The purpose of this aggregate data is to provide a National Level overview of the number of patients waiting for modalities of CT, MR and US.

This report is not intended to be used for the active management of hospital diagnostics waiting list, local reports and mechanisms should continue to be used for the management of diagnostics waiting lists at hospital level.
