# European Parliament Plenary Session Strasbourg Coming Week Highlights

**President's diary.** President Roberta Metsola will meet Sweden's Prime Minister Ulf Kristersson on Tuesday morning before the plenary debate, and afterwards they will hold a joint press conference. On Thursday and Friday, President Metsola will be in Davos, Switzerland, to participate in the World Economic Forum Annual Meeting, where on Thursday she will take part in a panel discussion on "Widening Europe's Horizons" and meet Croatian Prime Minister Andrej Plenković.

**Digital workers.** On Monday, President Metsola will announce a draft mandate to start negotiations with Council on measures to improve working conditions for workers on digital labour platforms. MEPs will have until Tuesday at midnight to decide whether to endorse or object to the mandate, and if enough objections are registered a plenary vote will be held on Thursday. The Parliament's Media Directorate will organise a briefing for journalists with the lead MEP on this issue on Wednesday lunchtime.

**Waste shipments.** MEPs will adopt their position ahead of talks with EU governments on a new law to reform EU procedures and control measures for waste shipments. The aim is to improve the environment and human health, while taking full advantage of the opportunities provided by waste for achieving a circular and zero-pollution economy. (debate Monday, vote Tuesday)

**Swedish EU Council Presidency.** On Tuesday at 9.00, MEPs will discuss the programme of Sweden's six-month Presidency of the Council, which started on 1 January, with Prime Minister Ulf Kristersson. Parliament's President Roberta Metsola and Prime Minister Kristersson will hold a joint press conference after the debate.

**Prosecution of Russian war criminals.** On Tuesday afternoon, MEPs will quiz Commission representatives on the prospects of establishing a tribunal to consider prosecuting Russia for the crime of aggression against Ukraine. A resolution will be put to the vote on Thursday.

**30th anniversary of the EU Single Market**. After a short ceremony and debate with the Commission on Monday afternoon, on Wednesday MEPs will adopt a resolution on the 30th anniversary of the EU single market.

**Election of a new EP Vice-President.** MEPs will, on Wednesday, choose a new Parliament Vice-President following the removal of Eva Kaili.

**Key debate/EU summit.** On Wednesday morning, MEPs will debate the results of the 15 December EU summit and current affairs with European Council President Charles Michel and Commission President Ursula von der Leyen.

**Uber lobbying in the EU.** On Wednesday afternoon, MEPs will discuss with the Council and the Commission recent revelations concerning Uber's former lobbying practices in the EU, the situation of Uber drivers in Europe, and the extent to which Uber's lobbying activities have affected their labour and social rights.

Protest crackdown and executions in Iran. On Tuesday afternoon, MEPs will discuss the EU's

response to the protests and executions in Iran with EU Foreign Policy Chief Josep Borrell. A resolution will be put to the vote on Thursday.

### Eurobarometer survey: Europeans concerned by cost of living crisis and expect additional EU measures

#### **Highlights from Eurobarometer Survey:**

The rising cost of living is the most pressing worry for 93% of Europeans, followed by the threat of poverty and social exclusion (82%)

Recent crises strengthened citizens' support for the European Union: 72% believe that their country has benefited from being a member of the EU and 62% see EU membership as a "good thing"

Citizens expect the EU to continue working on solutions to mitigate the effects of the consecutive crises

### Antitrust: Commission invites comments on draft Guidelines for sustainability agreements in agriculture

On Tuesday, the Commission launched a public consultation inviting all interested parties to comment on its draft proposal for Guidelines on how to design sustainability agreements in the field of agriculture ('Guidelines') using the novel exclusion from EU competition rules introduced during the recent reform of the common agricultural policy ('CAP').

### Foreign Subsidies Regulation: rules to ensure fair and open EU markets enter into force

On Wednesday, the <u>Foreign Subsidies Regulation</u> ('FSR') entered into force. This new set of rules for addressing distortions caused by foreign subsidies will allow the EU to remain open to trade and investment, while ensuring a level playing field for all companies operating in the Single Market. The Regulation was proposed by the Commission in <u>May 2021</u> and agreed by the European Parliament and the Council in record-time, in <u>June 2022</u>.

#### **State Aid**

**Denmark.** The Commission approved, under EU State aid rules, a €1.1 billion <u>Danish scheme</u> to support the roll-out of carbon capture and storage ('CCS') technologies. The measure contributes to the achievement of Denmark's climate targets and the <u>EU's strategic objectives under the European Green Deal</u>, in particular the 2050 climate neutrality goal.

### European Citizens' Initiative: Commission decides to register a new initiative on safeguarding fundamental rights at the EU's borders

The Commission has decided to register a European citizens' initiative (ECI) entitled 'Article 4: Stop torture and inhuman treatment at Europe's borders'.

The Initiative calls for a framework ensuring compliance with the prohibition of violence and inhuman and degrading treatments enshrined in Article 4 of the Charter of Fundamental Rights in relation to the EU policies concerning border controls, asylum and immigration.

#### **Next Steps**

Following today's registration, the organisers have six months to open the signature collection. If a European Citizens' Initiative receives one million statements of support within one year, from at least seven different Member States, the Commission will have to react. The Commission could decide to take the request forward or not, and will be required to explain its reasoning.

The decision to register is of a legal nature and it does not prejudge the final legal and political conclusions of the Commission on this initiative and the action it will intend to take, if any, in case the initiative obtains the necessary support.
