The regulations provide for reconciliation for (1) ill health reasons, (2) attendance by a member abroad in the performance of his/her duties as a member or office holder, or elsewhere in the state on behalf of a committee or (3) extraordinary circumstances which the appropriate authority determines are good and sufficient and could not have been foreseen. Administrative reconciliations are recorded based on specified evidence of attendance in Leinster House.
