For the purpose of Article 17.2 of the Constitution, the Government recommend that it is expedient to authorise such charges on and payments out of the Central Fund or the growing produce thereof and such payments out of moneys provided by the Oireachtas as are necessary to give effect to any Act of the present session to amend and extend the Social Welfare Acts and, for the purpose of giving effect to Directive 2003/41/EC of the European Parliament and of the Council and for other purposes, to amend and extend the Pensions Act 1990.
