- the increasing numbers of shooters coming to this country indiscriminately destroying many species of wild-birds;
- abuses related to live exports of farm animals; and

resolves to act in each of the cases set out above and where appropriate outlaw such activities and ensure that only the highest standards in animal welfare shall be permitted forthwith in Ireland." — *Tony Gregory*.

- resolves that the circumstances warrant the immediate suspension of overflight and landing privileges granted by the Government to military and civilian chartered aircraft conveying US troops to Iraq, and instructs the Government to act accordingly;
- calls on the Irish people to peacefully register their opposition to the occupation of Iraq and to Irish collusion in that occupation on the occasion of the US President's visit to Ireland during the US-EU Summit; and

- the study 'Statement on Prices and Costs', by the National Competitiveness Council (NCC) which concluded that the Irish pay more for food and rent than consumers in any other euro zone country;
- the publication of a Disability Bill in which the much heralded rights are minimal and the finances unclear;
- the continued targeting of young people by alcohol distributors and the lack of action to tackle binge drinking and other alcohol related problems in society;
- almost one third of primary school children in disadvantaged areas suffer from severe literacy problems;
- the spiralling rates of obesity resulting from unhealthy eating habits and lack of exercise;
- the deteriorating situation in Iraq where it is clear that the interim Government, propped up by occupying forces, cannot establish any kind of democratic structures;
- the failure of the Sudanese Government to stop atrocities in the Darfur region;
