TEACHTAIREACHTAÍ ÓN RIALTAS MESSAGES FROM THE GOVERNMENT

An Bille Cógaisíochta 2007. Pharmacy Bill 2007.

For the purpose of Article 17.2 of the Constitution, the Government recommend that it is expedient to authorise such payments out of moneys provided by the Oireachtas as are necessary to give effect to any Act of the present session to make new provision for the regulation of pharmacy, including provision for the dissolution of the Pharmaceutical Society of Ireland and the setting up of a new Pharmaceutical Society of Ireland, for the establishment, constitution and functions of the new society's council, for a new system of registration of qualified pharmacists, druggists and pharmaceutical assistants and of pharmacies, for the creation of certain offences relating to pharmacy and for the setting up of new procedures to ensure that pharmacists are and continue to be fit to practise and to prevent pharmacists, pharmacy owners and medical practitioners from entering into certain inappropriate relationships; and to provide for related matters.
