1. To delete all words after "That," and substitute the following:

“Dáil Éireann notes:

- that legislative reform must be fully consistent with the relevant provisions of the Constitution;
- the options identified by the Colley Group, including in particular for same-sex couples;
- the Tenth Report of the All-Party Oireachtas Committee on the Constitution, on the Family, which recommended that civil partnership legislation should be provided for same-sex couples;
- the report of the Law Reform Commission on the Rights and Duties of Cohabitants, which recommended provision of a redress mechanism for vulnerable dependent

- cohabitants at the termination of a relationship; and
- the Government's decision reflected in the Government Legislative Programme published on 27th September, 2007 to prepare a scheme of a Bill;
- supports the commitment in the Agreed Programme for Government to legislate for Civil Partnership at the earliest possible date in the lifetime of the Government, so as to establish a supportive legal framework for same-sex couples in committed relationships.” — *An tAire Dlí agus Cirt, Comhionannais agus Athchóirithe Dlí.*
