- (ii) the despatch, pursuant to section 2 of the Defence (Amendment) (No. 2) Act 1960, as applied by the Defence (Amendment) Act 2006, of a contingent of the Permanent Defence Force for service with the United Nations Mission in the Central African Republic and Chad (MINURCAT), established under the authority of United Nations Security Council Resolution 1861 (2009) of 14 January, 2009; and
- (iii) the continued deployment of personnel with EUFOR TCHAD/RCA during the handover period and pending the completion of the withdrawal of EUFOR TCHAD/RCA.”

For the purpose of Article 17.2 of the Constitution, the Government recommend that it is expedient to authorise such payments out of moneys provided by the Oireachtas as are necessary to give effect to any Act of the present session to provide for the establishment of tribunals from time to time to inquire into and report on matters of urgent and significant public importance; to provide for the powers of such tribunals and their suspension and dissolution; to repeal the Tribunals of Inquiry (Evidence) Acts 1921 to 2004; and to provide for related matters.
