Bille dá ngairtear Acht do dhéanamh socrú i ndáil leis na fineálacha uasta a fhéadfaidh cúirt a fhorchur i leith cionta a thrailtear go hachomair agus cionta áirithe a thrailtear ar díotáil; do dhéanamh socrú go ndéanfaidh cúirt, a mbeidh fineáil á forchur aici ar dhuine a chiontú i gcion, dálaí airgeadais duine a chur i gcuntas; do dhéanamh socrú maidir le fineálacha den sórt sin a ioc ina dtráthchodanna in imthosca áirithe; do dhéanamh socrú i ndáil le cumhactháil na cúirte i gcás inar mhainnígh duine ciontaithe fineáil a ioc; chun na gcríoch sin do leasú an Acharta um Cheartas Coiriúil (Seirbhís Pobail) 1983 agus Acht na gCúirteanna (Uimh. 2) 1986; agus do dhéanamh socrú i dtaobh nithe a bhaineann leis an méid sin.

Bill entitled an Act to make provision in relation to the maximum fines that a court may impose in respect of offences tried summarily and certain offences tried on indictment; to provide that a court in imposing a fine upon conviction of a person of an offence shall take account of a person's financial circumstances; to provide for the payment of such fines by instalment in certain circumstances; to make provision in relation to the powers of the court where there has been a failure on the part of a convicted person to pay a fine; for those purposes to amend the Criminal Justice (Community Service) Act 1983 and the Courts (No. 2) Act 1986; and to provide for matters connected therewith.
