Bill entitled an Act to give effect to Directive No. 2006/24/EC of the European Parliament and of the Council of 15 March 2006 on the retention of data generated or processed in connection with the provision of publicly available electronic communications services or of public communications networks and amending Directive 2002/58/EC, to provide for the retention of and access to certain data for the purposes of the prevention of serious offences, the safeguarding of the security of the State and the saving of human life, to repeal Part 7 of the Criminal Justice (Terrorist Offences) Act 2005, to amend the Interception of Postal Packets and Telecommunications Messages (Regulation) Act 1993 and to provide for related matters.

- fáilte a chur roimh an tionscnamh ag Fondúireacht Nelson Mandela agus ag eagraíochtaí gaolmhara ceiliúradh a dhéanamh, an 18 Iúil, ar na héachtaí atá déanta i rith a shaoil ag Nelson Mandela, ar éachtaí iad a chuaigh i gcion ar dhaoine ar fud an domhain;

 - a aithint maidir le cosantóirí misniúla chearta an duine – ar daoine iad nach staonann de labhairt amach in aghaidh na héagóra, in aghaidh an leatroidim, agus in aghaidh dínit an duine a shéanadh, dá dheacra a bhíonn na cúinsí go minic – gur mó a theastaíonn siad inniu ná riamh; agus
 - a thabhairt dá haire go bhfuil ionad ar leith i gcroí mhuintir na hÉireann ag oidhreacht Nelson Mandela, agus ag na príonsabail agus ag an bhfealsúnacht ar thug sé seasamh dóibh.
- welcomes the initiative of the Nelson Mandela Foundation and related organisations to celebrate, on 18th July, the lifetime of achievements of Nelson Mandela, which have been felt all over the world;
- commends the Foundation for honouring Nelson Mandela’s service to humanity by giving people of the world the opportunity of his birth date to embrace his values, through seeking to improve their lives through service to their communities;
- honours the transformative and courageous leadership of Nelson Mandela who devoted his life to peace, justice and a better life for all;
