Bille dá ngairtear Acht do dhéanamh socrú maidir le daoine áirithe atá á gcoinneáil a chur faoi choimeád sealadach d'fhonn a urasú go láithreoidh na daoine sin os comhair cúirte; do dhéanamh socrú maidir le hoifigí cúirte comhcheangailte a bhunú; do leasú an Achta um Sheirbhís Chúirteanna 1998, an Achta um Nós Imeachta Coiriúil 1967 agus an *Petty Sessions (Ireland) Act* 1851, agus do dhéanamh socrú i dtaobh nithe gaolmhara.

Bill entitled an Act to provide for the placement in temporary custody of certain detained persons in order to facilitate their appearance before a court; to provide for the establishment of combined court offices; to amend the Courts Service Act 1998, the Criminal Procedure Act 1967 and the Petty Sessions (Ireland) Act 1851, and to provide for related matters.

Bille dá ngairtear Acht do chur athchóiriú an dlí reachtúil chun cinn trí aisghairm a dhéanamh ar reachtanna áirithe de shraith shonraithe a achtaíodh an 31 Nollaig 1750 nó roimhe agus ar reachtanna áirithe eile de shraith shonraithe eile a achtaíodh an 31 Nollaig 1850 nó roimhe agus a bhfuil scortha acu d'éifeacht a bheith leo nó atá éirithe neamhriachtanach, trí na reachtanna sin a shainaithe a achtaíodh amhlaidh ach nach bhfuil á n-aisghairm leis an Acht seo, trí ghearrtheidil a shannadh do reachtanna áirithe d'fhonn a lua a éascú agus trí reachtanna áirithe a leasú a mhéid a bhaineann siad le gearrtheidil, agus do dhéanamh socrú i dtaobh nithe gaolmhara.

Bill entitled an Act to promote the revision of statute law by repealing certain statutes of a specified series that were enacted on or before 31 December 1750 and certain other statutes of another specified series that were enacted on or before 31 December 1850 and which have ceased to have effect or have become unnecessary, by identifying those statutes that were so enacted but are not being repealed by this Act, by assigning short titles to certain statutes in order to facilitate their citation and by amending certain statutes in so far as they relate to short titles, and to provide for related matters.
