TEACHTAIREACHTAÍ ÓN RIALTAS
MESSAGES FROM THE GOVERNMENT

An Bille Uchtála 2009.
 Adoption Bill 2009.

For the purpose of Article 17.2 of the Constitution, the Government recommend that it is expedient to authorise such payments out of moneys provided by the Oireachtas as are necessary to give effect to any Act of the present session to provide for the dissolution of An Bord Uchtála and the establishment of a body to be known as Údarás Uchtála na hÉireann and in the English language as the Adoption Authority of Ireland; to provide for matters relating to the adoption of children; to give the force of law to the Convention on the Protection of Children and Co-operation in Respect of Intercountry Adoption signed at the Hague on 29 May 1993; to provide for the making and recognition of intercountry adoptions in accordance with bilateral agreements and with other arrangements; to provide for the recognition of certain adoptions effected outside the State; to repeal the Adoption Acts 1952 to 1998; and to make consequential amendments to other Acts and to provide for related matters.
