Bille dá ngairtear Acht do dhéanamh socrú maidir le hairgead, ar buaiteachais neamhéisilthe é, a aistriú chuig ciste ar a dtabharfar an Ciste Buaiteachas Neamhéisilthe, do thabhairt feidhmeanna do Ghníomhaireacht Bainistíochta an Chisteáin Náisiúnta i ndáil leis an gciste a rialú agus a bhainistiú, do dhéanamh socrú maidir le hairgead a eisíoc (lena n-áirítear airgead a aisíoc le daoine a bhfuil teideal acu chuige) as an gciste, do shocrú tréimhse ama nach mbeidh teideal a thuilleadh ag buaiteoirí chuig buaiteachais neamhéisilthe dá héis, do bhunú comhlachta ar a dtabharfar an Bord Buaiteachas Neamhéisilthe agus do mhíniú a fheidhmeanna, do dhéanamh socrú maidir le scéim shainordaitheach coimeádta taifead do sholáthraithe seirbhísé i réimsí gealltóireachta, cearrbhachais agus crannchur, do dhéanamh socrú maidir le cigirí a cheapadh, agus do dhéanamh socrú i dtaobh nithe gaolmhara.

Bill entitled an Act to provide for the transfer of moneys that constitute unclaimed winnings to a fund to be known as the Unclaimed Winnings Fund, to confer functions on the National Treasury Management Agency in relation to the control and management of the fund, to provide for the disbursement of moneys (including the repayment of moneys to persons entitled to them) from the fund, to set a time period after which winning parties are no longer entitled to unclaimed winnings, to establish a body to be known as the Unclaimed Winnings Board and to define its functions, to provide for a mandatory scheme of record-keeping for service providers in the fields of betting, gaming and lotteries, to provide for the appointment of inspectors, and to provide for related matters.
