rejecting the Report of the Joint Committee on Agriculture, Fisheries and Food on the Ombudsman’s Special Report, laid before Dáil Éireann on 20th October, 2010, including in particular the conclusions of the Joint Committee:

- that the manner in which the scheme was advertised was not adequate but not to the extent that it could be considered contrary to fair and sound administration;
- rejecting the Ombudsman’s views in relation to the design of the scheme; and
