Fógraí i dtaoibh leasú ar Thairiscint : Notices of Motions

5a. “D'ainneoin aon ní sna Buan-Orduithe—

- (1) an Roghchoiste atá bunaithe faoi Bhuan-Ordú 103 (dá ngairfear Roghchoiste Bhuan-Ordú 103), ceapfaidh na hAoirí trí chomhalta dhéag dó;
- (2) Aire nó Aire Stáit a fhógróidh ainmneacha na gcomhaltaí a cheapfar faoi mhír (1) i dtreo go mbeidh a fhius ag an Dáil iad ar an gcéad lá a shuifidh sí tar éis a gceaptha;
- (3) beidh cruinniú ag an Roghchoiste más gá chun na feidhmeanna seo a leanas a chomhlíonadh:
  - (a) breithniú a dhéanamh ar riachtanas ionchasach a bheith le tuairim réasúnaithe nach bhfuil dréacht-acht reachtúil ag comhlíonadh phrionsabal na coimhdeachta dár foráladh i mír (1) de Bhuan-Ordú 105;
  - (b) cibé fograí faoi mhír (1) de Bhuan-Ordú 106 dá dtarchuirfear chuige ag Dáil Éireann, a bhreithniú; agus
  - (c) sáruithe ionchasacha ar phrionsabal na coimhdeachta a bhreithniú, dár

That, notwithstanding anything in Standing Orders—

- (1) the Whips shall appoint thirteen members to the Select Committee standing established under Standing Order 103 (which shall be called the Standing Order 103 Select Committee);
- (2) a Minister or Minister of State shall announce the names of the members appointed under paragraph (1) for the information of the Dáil on the first sitting day of the Dáil following their appointment;
- (3) the Select Committee shall meet where necessary to perform the following functions:
  - (a) to consider the potential requirement for a reasoned opinion that a draft legislative act does not comply with the principle of subsidiarity as provided for in paragraph (1) of Standing Order 105;
  - (b) to consider such notifications under paragraph (1) of Standing Order 106 as may be referred to it by Dáil Éireann; and
  - (c) to consider potential infringements of the principle of subsidiarity as

(a) Standing Order 83, other than those set out in paragraph (4) thereof; and

(b) Standing Orders 105, 106 and 107.”
