- 5a.** “D’ainneoin aon ní sna Buan-Orduithe— That, notwithstanding anything in Standing Orders—
- (1) an Roghchoiste atá bunaithe faoi Bhuan-Ordú 103 (dá ngairfear Roghchoiste Bhuan-Ordú 103), ceapfaidh na hAoirí trí chomhalta dhéag dó; (1) the Whips shall appoint thirteen members to the Select Committee standing established under Standing Order 103 (which shall be called the Standing Order 103 Select Committee);
- (2) Aire nó Aire Stáit a fhógróidh ainmneacha na gcomhaltaí a cheapfar faoi mhír (1) i dtreo go mbeidh a fhios ag an Dáil iad ar an gcéad lá a shuífidh sí tar éis a gceaptha; (2) a Minister or Minister of State shall announce the names of the members appointed under paragraph (1) for the information of the Dáil on the first sitting day of the Dáil following their appointment;
- (3) beidh cruinniú ag an Roghchoiste más gá chun na feidhmeanna seo a leanas a chomhlíonadh: (3) the Select Committee shall meet where necessary to perform the following functions:
- (a) breithniú a dhéanamh ar riachtanas ionchasach a bheith le tuairim réasúnaithe nach bhfuil dréacht-acht reachtúil ag comhlíonadh phrionsabal na coimhdeachta dár foráladh i mír (1) de Bhuan-Ordú 105; (a) to consider the potential requirement for a reasoned opinion that a draft legislative act does not comply with the principle of subsidiarity as provided for in paragraph (1) of Standing Order 105;
- (b) cibé fograí faoi mhír (1) de Bhuan-Ordú 106 dá dtarchuirfear chuige ag Dáil Éireann, a bhreithniú; agus (b) to consider such notifications under paragraph (1) of Standing Order 106 as may be referred to it by Dáil Éireann; and
- (c) sárúithe ionchasacha ar phrionsabal na coimhdeachta a bhreithniú, dár (c) to consider potential infringements of the principle of subsidiarity as
