For the purpose of Article 17.2 of the Constitution, the Government recommend that it is expedient to authorise such payments out of moneys provided by the Oireachtas as are necessary to give effect to any Act of the present session to facilitate the lending of money to microenterprises; for that purpose to make provision for a fund to be known as the Microenterprise Loan Fund; to provide for the formation of a company to manage that fund; and to provide for matters connected therewith.

against children, or certain arrestable offences (including certain sexual offences) against such adults, in certain circumstances; to provide for the amendment of section 9 of the Offences Against the State (Amendment) Act 1998; to amend section 16 of the Criminal Justice (Female Genital Mutilation) Act 2012; and to provide for related matters.
