Leasuithe: Amendments:

*1.* To insert the following after "19th December, 2014":

"but calls on the Government to amend the Commission's terms of reference to insert the following new section:

'The Commission is further directed:

- (a) to liaise with the non-statutory "Independent Review Mechanism", and include those cases containing similar issues to those contained in the Guerin Report regarding the failure and inadequacy of Garda investigations and containing allegations of Garda malpractice;
- (b) to conduct a root and branch review of policing structure in Ireland and consistency of, and adherence to, practices and the adequacy of management and supervisory procedures on a nationwide basis as required by the issues raised and conclusions reached by Mr. Guerin in Chapters 17, 18, 19 and 20 of his report, and as further identified by the Garda Inspectorate in their Addendum Chapter on the Guerin Report; and
- (c) to carry out an examination of the adequacy of the internal disciplinary investigation process, particularly in relation to Gardaí of senior rank, and the roles of an Garda Síochána and the Garda Síochána Ombudsman Commission, which the Garda

Inspectorate has noted is an important theme of the Guerin Report which was not examined in the Garda Inspectorate report."." — *Mick Wallace, Clare Daly.* 

2. To insert the following after "19th December, 2014":

"but calls on the Government to amend the Commission's terms of reference to insert the following:

'The Commission is further directed:

- (a) all recommendations included in the Guerin Report shall form part of this Commission of Investigation; and
- (b) these terms of reference can be amended to include further cases currently being considered by the non-statutory "Independent Review Mechanism" where the cases under review by this mechanism are of a similar character, with elements including Garda malpractice, lack of adequate investigation of an alleged crime committed or other inadequacies referred to in the Guerin Report.
